#### Revised 2025 Office of the City Auditor Annual Work Plan:

At the November 29, 2024, Audit Committee meeting, Committee approved the Office of the City Auditor's original 2025 Annual Work Plan. Staffing changes and the increase in investigation has reduced our capacity to complete all the audits included in this Plan.

To determine which audits to remove we looked at our schedule, we had discussions with senior management, and we reevaluated the risks each of the audits would address.
