"Maintain the North Saskatchewan River Valley and Ravine System's key role as an environmental protection area and for open space, cultural and recreational uses."


Breathe: Green Network Strategy




River Valley ARP Renewal

- Updates the North Saskatchewan River Valley Area Redevelopment Plan, Bylaw 7188 (February 1985)
- Sets overall land use pattern for the River Valley and Ravine System
- Limits development for purposes other than open space
- Identifies high-level decision making framework for development proposals



Plan Objectives

- Ensure the environmental protection of the River Valley and Ravine System
- Provide public access for celebration and wellness



Plan Direction

- Provides direction to City Administration and City Council when evaluating development proposals
- Existing uses and development rights acknowledged
- New uses, other than those compatible with open space use, are discouraged or not supported outside of Rossdale and Cloverdale



River Valley Open Space

Lands that are part of the public open space network are designated as **River Valley Open Space** and planned in accordance with the Ribbon of Green Strategic Plan

Decision-Making Framework: City Council Approval Requirements

- Intensive open space, intensive transportation, or intensive utility facilities
- Development with long-term or permanent environmental or community impacts that cannot be mitigated
- Plan amendments
- Rezoning applications for zones other than A River Valley Zone or NA -Natural Areas Zone
