Formation of Edmonton Cultural Trust Foundation Announced

The Edmonton Cultural Trust Foundation, a community charitable organization devoted to supporting and sustaining arts and culture in Edmonton, was officially announced today. The Edmonton Cultural Trust will be the beneficiary of excess revenue flowing from the Edmonton Galleria Project after theatre operations. The Trust may also become involved in other projects that will generate additional sources of income for the Trust. Five Founding Trustees and an Executive Director were announced to lead the Trust's development.

First and foremost a fundraiser in that position, he was also responsible for the overall financial management of the department, policy development in fundraising, university endowment management, and advising on charitable receipting and valuations of gifts. In addition, he has been a professional clarinetist in Edmonton and Toronto, as well as being associated with a number of fine arts associations in Edmonton, Canada and internationally. Mr. Cook is currently Chair of the Edmonton Opera.



Dianne Kipnes, Founding Trustee

Clinical Psychologist

Dianne Kipnes has been a long-time supporter of community endeavours that improve Edmontonians' quality of life. She has been a board member or chairperson of many charitable organizations including the Alberta Cancer Foundation, the TELUS Community Foundation, Edmonton Opera Association, and the National Arts Centre. In 2011, she co-chaired the Mayor's Arts Visioning Committee, which confirmed the need to build more suitable, affordable and accessible performing arts space in Edmonton. This led to the creation of the Edmonton Downtown Academic and Cultural Centre Foundation, of which she is the chair. Dr. Kipnes' many recognition honours include the Alberta Centennial and Queen Elizabeth II Jubilee Diamond medals.



John Mahon, Executive Director

John Mahon is a classical musician and the former Executive Director of the Edmonton Arts Council. He retired from that position in 2013. Mr. Mahon's career path has involved him in almost every aspect of Edmonton's arts community. In addition to his new role as the Edmonton Cultural Trust Foundation's Executive Director, Mr. Mahon has been an active performer on the clarinet, a local record producer, and is currently a part-time instructor within Grant MacEwan University's Arts and Cultural Management program. He has Bachelor of Music and MBA degrees from the University of Alberta and has studied at the Royal College of Music in London, England.

Overview

The Edmonton Cultural Trust Foundation concept is modelled after the Pittsburgh Cultural Trust, a not-for-profit organization that uses income generated from real estate to support and sustain arts and culture in Pittsburgh.

The Edmonton Cultural Trust Foundation is the sole beneficiary of the Edmonton Galleria Project. After debt servicing and covering any theatrical operational shortfall, excess cash from all phases of the Galleria development will flow to the Cultural Trust to be used for the sustainability of arts and culture in Edmonton. The Edmonton Cultural Trust Foundation will be overseen by a diverse, community-based Board of Trustees. Key objectives are to:

- Provide sustainable funding for arts and culture in Edmonton through the excess cash flow from the Edmonton Galleria Project and other real estate developments which the Edmonton Cultural Trust may undertake.
- Contribute to city building by contributing to a vibrant Arts District, starting in the Edmonton Galleria Project itself and running down 99th Street to Jasper Avenue and the Shaw Convention Centre.
- Create places that give people more reasons to be in the Arts District and encourage people to live, work and play downtown.

It is projected that the Cultural Trust's excess cash flow from the completed Edmonton Galleria Project will be significant.

The <u>Pittsburgh Cultural Trust</u> was established as a philanthropic trust in 1984. It is a unique model of how public-private partnerships can support the arts through innovation, creativity and collaboration. The best of touring Broadway, contemporary dance, family events and cutting-edge visual arts are among the variety of arts and entertainment it presents and exhibits. Hundreds of artists, thousands of students and millions of people expand their horizons in the Pittsburgh Cultural Trust's theatres, galleries, and public art environments.

The Edmonton Cultural Trust Foundation has the advantage of beginning within a city that has an active downtown Arts District and vibrant arts and culture community. The Edmonton Cultural Trust recognizes these strengths and will work to build upon them for the betterment of all Edmontonians. A focus of the Edmonton Cultural Trust will be to find more ways to draw people to 99 Street and Churchill Square. It will be the Trust's goal to work with the City of Edmonton to accomplish this.
