Impact of the Provincial Budget

- Traffic offence fines will increase an average of 35%
- 10% retained by the Province as administration fee
- Traffic safety revenue for 2015 anticipated to increase:
 - \$300 thousand for Edmonton Police Service
 - \$6.8 million for Office of Traffic Safety
- Traffic safety revenue for 2016 anticipated to increase:
 - \$3.4 million for Edmonton Police Service
 - \$14 million for Office of Traffic Safety



Annualization

- 35 positions approved in 2015
 - Tax levy impact of \$2.4 million
 - Annualization impact \$2.6 million; to be included in 2016 budget submission
 - Recruitment is underway, all positions in place by December 2015.
- EPS assessment growth allocation previously used to offset costs, however methodology of this calculation changed in 2015
- Annualization could be funded through Provincial fines revenues



Downtown & Transit Policing

Goal: Support the safe and vibrant revitalization of downtown Edmonton and the expanded LRT

- Proactive model of policing will address challenges posed by downtown and LRT growth
- Effectively deal with criminal activities and disorder
- Build a flexible workforce for visibility, problem solving, hospitality policing
- Result: positive reputation for downtown and LRT




Research

- Crime and disorder workload projections for planned and proposed developments in the downtown
- Trend analysis of crime and disorder in licensed establishments city-wide and downtown
- Site visits to LA Live, Staples Center, Los Angeles Police,
 Columbus Nationwide Arena, Columbus Police
- Evaluation of Transit and Police Partnership (TAPP) pilot



Impact of Proposed Developments

- In 2016, police workload downtown is projected to increase by a minimum of 14%
- New downtown development worth \$3.5 billion including:
 - Rogers Place
 - Stantec Tower
 - Delta Hotel
 - Kelly Ramsay Building
 - Royal Alberta Museum
 - Numerous condo towers




Impact of Licensed Establishments

- Currently 47,000 licenced seats in downtown Edmonton
- 37% of incidents in licensed establishments occurred in Downtown Division
- Number of police calls to downtown establishments has increased by 24% since 2010; rest of the city increased by 12%
- As more licensed establishments are opened downtown, workload will increase
- Largest increases in were seen in assaults, "trouble with person", and "trouble with intoxicated person" calls



Impact of Licensed Establishments





Downtown Revitalization Policing

- 40 positions
- 7 days per week coverage
- 4 separate squads
- Foot, bicycle, Segway, and car-based patrols
- Focus on:
 - Social disorder
 - General safety and security
 - Event policing
 - Entertainment District

Full funding available through provincial fine revenue increases



Transit and Police Partnership (TAPP)

Pilot Project (July-December 2014)

- 4 EPS constables
- Central and north LRT stations

Goals

- Visibility
- Crime prevention, intervention and suppression
- Decrease fear and increase safety

Results

- 47% increase in LRT arrests during pilot
- Positive feedback from transit users regarding police presence on LRT



Transit Policing

- Working in partnership with Transit Peace Officers
- Similar to TAPP pilot program
- 1 Sergeant
- 8 Constables

Cost

2016 (Annualization)	\$	712,000
Annual Operating	\$ 1	,424,000
2016 (1 Time Costs)	\$	291,000
Total 2016	\$ 1	1,715,000
