# **Bylaw 17127**

Designation of Municipal Reserve - Mayliewan Park

## **Purpose**

To designate two lots in Mayliewan Park as Municipal Reserve in accordance with the *Municipal Government Act*.

#### Readings

Bylaw 17127 is ready for three readings. If Council wishes to give three readings during a single meeting, Council must unanimously agree "That Bylaw 17127 be considered for third reading."

#### **Position of Administration**

Administration supports this Bylaw

#### **Report Summary**

Administration recommends the parcels described as Plan 002 1663, Block 55, Lot B; Plan 002 1663, Block 55, Lot C for the Mayliewan Neighbourhood Park site be designated as Municipal Reserve.

## Report

The Mayliewan Neighbourhood Park site is comprised of seven parcels. These parcels were created over time under a number of subdivisions to assemble/establish the park site. Six of the seven parcels are currently designated as Municipal Reserve. One parcel is zoned Public Park and six parcels are zoned Urban Reserve.

Administration is in the process of reconciling the application of the Municipal Reserve designation, updating the land use zoning, and consolidating parcels (where five or more exist), for a number of park sites.

Bylaw 17127 will make the Mayliewan Neighbourhood park site uniformly Municipal Reserve and thereby allow the consolidation of all parcels to eliminate potential future cross lot servicing constraints. A Bylaw to rezone the Urban Reserve zoned parcels will be advanced to a future Public Hearing meeting of City Council.

## Policy

Edmonton's Urban Parks Management Plan – 2006 – 2016:

 Principle 9: Effective and Efficient - City actions demonstrate a strong commitment to managing land, financial resources and human resources to support the recreational, social and environmental needs of the community.

#### **Corporate Outcomes**

This report contributes to the corporate outcome "Edmontonians use facilities and services that promote healthy living" by facilitating the consolidation and future development of Mayliewan Park, which will provide the physical and social environment,

and variety of programs and services that enable Edmontonians to lead healthy, active lives.

## **Legal Implications**

Pursuant to section 665 of the *Municipal Government Act*, City Council may by bylaw require that the Registrar of the Land Titles Office designate a parcel of land that the City owns as Municipal Reserve.

Once a parcel of land is designated as Municipal Reserve, it can only be used for Municipal Reserve purposes as set out in section 671(2) of the *Municipal Government Act*. In order to dispose of the parcel, such as selling or leasing it, the designation would have to be removed through a City Council motion, pursuant to section 675 of the *Municipal Government Act*.
