ANIMAL CARE AND CONTROL BYLAW 21244 Amendment No. 1

Edmonton City Council enacts:

1. Bylaw 21244, Animal Care and Control Bylaw, is amended by this bylaw.
2. Section 2(2)(q)(iv) is deleted and replaced with:

DEFINITIONS 2(2)(q)(iv) section 14(1)(a) or 14(1)(b); or,

3. Section 2(2)(q)(v) is deleted and replaced with:

DEFINITIONS 2(2)(q)(v) Section 15(1)(a) or 15(1)(b) of Public Spaces Bylaw 20700;

4. Section 2(2)(v) is amended by deleting and replacing “Return to Field” with “Return-to-Field”.
5. Section 2(2)(x)(i) is amended by deleting “, or other wound”.
6. Section 2(2)(x)(ii) is amended by adding “wounds requiring” before “repair”.
7. Section 2(2)(x)(v) is amended by deleting “up to”.
8. Section 8(1) is amended by adding “of this bylaw” after “Schedule A”.
9. Section 14(1)(b) is amended by adding “chase,” before “Attack”.
10. Section 15(1)(b) is amended by deleting and replacing “while outdoors” with “at all times while it is off the property of the Owner”.

11. Section 15(1)(d) is deleted and replaced with:

**LICENCE
CONDITIONS** 15(1)(d) that the Licensee or Owner of the Nuisance dog complete behavioural training as directed by and to the satisfaction of the City Manager; or,

12. Section 18(1)(a) is deleted and replaced with:

**LICENCE
CONDITIONS** 18(1)(a) require the Licensee or Owner to undertake and complete behavioural training as directed by and to the satisfaction of the City Manager by a specified date;

13. Section 21(1)(a) is amended by deleting “damage property or” before “chase” and adding “or damage property” after “Animal”.

14. Section 21(1)(b) is amended by adding “chase,” before “Attack”.

15. Section 22(1)(c) is deleted and replaced with:

**REVIEW OF
LICENCE** 22(1)(c) within the three years preceding the application, there have been no convictions or unresolved charges under this bylaw, Public Spaces Bylaw 20700, or the Animal Licensing and Control Bylaw 13145 relating to the Owner or the Vicious Dog;

16. Section 29(1) is amended by adding “of this bylaw” after “Schedule A”.

17. Section 33(1)(c) is amended by deleting “snakes,”.

18. Section 35(2) is amended by adding “of this bylaw” after “Schedule A”.

19. Section 39(11) is amended by deleting and replacing “Schedule “A” with “Schedule A of this bylaw”.

20. Section 42 is amended by adding the marginal note “NOTIFICATION OF STRAY & IMPOUNDMENT”.

21. Section 47(1) is amended by adding “of this bylaw” after “Schedule B”.

22. Section 55(1) is amended by adding “of this bylaw” after “Schedule A”.
23. Section 55(1)(b) is amended by deleting “or kennel”.
24. Section 64 is amended by deleting and replacing “May 1, 2026” with “May 19, 2026”.
25. Section 65(2)(a) is deleted and replaced with:

65(2)(a) in section 9, by adding section 9(d) following section 9(c):

9(d) “**serious injury**” includes any physical injury to a person or animal that requires medical attention, and includes:

- i) wounds requiring sutures;
- ii) wounds requiring repair and closing, or surgery;
- iii) disfiguring or scarring lacerations;
- iv) broken bones, severe pains, physical trauma, or
- v) any other injury assessed by a bylaw enforcement officer to be level 4 or higher on the Dunbar Dog Bite Scale, or an equivalent dog bite injury scale;

27. Section 65(2)(g) is deleted and replaced with:

65(2)(g) Part III of Schedule A is deleted and replaced with Schedule C of the Animal Care and Control Bylaw 21244.

28. The table in Schedule A - Fees is amended by deleting and replacing “\$38” in row 7 of column 2 with “\$23”.
29. The table in Schedule A - Fees is amended by deleting and replacing “\$39” in row 7 of column 3 with “\$24”.
30. The table in Schedule A - Fees is amended by deleting and replacing “\$40” in row 7 of column 4 with “\$25”.
31. Schedule A - Fees is amended by deleting “kennel” after “Relinquished Animal”.

32. The table in Schedule B - Fines is amended by adding “Chase,” before “Attack” in row 12 of column 2.
33. “Schedule C - Bylaw 20700, Public Spaces Bylaw Schedule A - Fines” is added after Schedule B, and all parts other than Part III - Animals are deleted from the table.
