

**THE CITY OF EDMONTON**  
**BYLAW 21424**  
**SPRING 2026 MINOR REVISIONS AND GENERAL REPEALS - BYLAWS, POLICIES**  
**AND MOTIONS BYLAW**

Edmonton City Council enacts:

1. Bylaw 21244, Animal Care and Control Bylaw, is amended as follows:
  - (a) in section 2(2)(s)(vi), by deleting and replacing “actual of apparent” with “actual or apparent”;
  - (b) by deleting and replacing section 2(2)(v) with:
    - (v) **“Return-to-Field”** means a program that may return an impounded Unowned Cat to the location where it was found and may include the provision of veterinary care, vaccination, or sterilization;
  - (c) in section 2(2)(z), by deleting and replacing “an identification” with “identification”;
  - (d) in section 10(2), by deleting and replacing “others consideration” with “others, consideration”;
  - (e) in section 24(2), by deleting and replacing “Return to Field” with “Return-to-Field”;
  - (f) in section 36, by deleting and replacing the marginal note with:

**LIMIT ON DOGS, NUISANCE DOGS, VICIOUS DOGS, CATS AND RABBITS**

- (g) by deleting and replacing section 42(2)(c) with:
  - (c) the consequences of failing to reclaim the Animal by the date set out in the notice including that such Animal may be transferred, adopted out, or euthanized.

2. Bylaw 18307, Subdivision and Development Appeal Board Bylaw, is amended by deleting and replacing section 17(1) with:

**ATIA HEAD**                    17    (1)    The chair is the head of the Subdivision and Development Appeal Board for the purpose of the *Access to Information Act*, SA 2024, c A-1.4.

3. Bylaw 18308, Assessment Review Boards Bylaw, is amended by deleting and replacing section 17(1) with:

**ATIA HEAD**                    17    (1)    The chair is the head of the Local Assessment Review Board and Composite Assessment Review Board for the purpose of the *Access to Information Act*, SA 2024, c A-1.4.

4. Bylaw 16620, City Administration Bylaw, is amended as follows:

- (a) sections 2(2)(k) and 2(2)(l) are deleted; and
- (b) section 17 is deleted and replaced with:

**ATIA HEAD**                    17            The City Manager is the head of the local public body for the purpose of the *Access to Information Act*, SA 2024, c A-1.4.

5. Bylaw 14600, Community Standards Bylaw, is amended as follows:

- (a) in section 4.1, by deleting and replacing “land deemed” with “land is deemed”; and
- (b) in section 6(2)(b.1), by deleting and replacing “visable” with “visible”.

6. Bylaw 18156, Council Committees Bylaw, is amended as follows:

- (a) sections 2(2)(i) is deleted; and
- (b) section 8 is deleted and replaced with:

**ATIA HEAD**                    8            The City Manager will be the head of the local public body for the purpose of the *Access to Information Act*, SA 2024, c A-1.4, and will provide records management support for all Standing

Committees and Council Committees.

7. Bylaw 15638, Edmonton Combative Sports Commission Bylaw, is amended as follows:

- (a) the preamble is deleted;
- (b) sections 2(k) and 2(1) are deleted;
- (c) in section 22, by deleting “and the FOIP Act”;
- (d) section 26 is deleted and replaced with:

26           The City Manager will be the head of the Commission for the purpose of the *Access to Information Act*, SA 2024, c A-1.4.

- (e) section 28(o) is deleted.

8. Bylaw 16368, Enforcement Bylaw, section 23(2) is amended by deleting “or 23(1)(b)”.

9. Bylaw 17138, Naming Committee Bylaw, is amended as follows:

- (a) sections 2(g) and 2(h) are deleted;
- (b) section 28(d) is deleted and replaced with:
  - (d) Provide City information or records to the Committee about matters within its mandate if requested, subject to applicable privacy legislation and other confidentiality requirements;
- (c) section 32 is deleted; and
- (d) Schedule A is deleted.

10. Bylaw 20700, Public Spaces Bylaw, is amended as follows:

- (a) section 6(e) is deleted;
- (b) section 65(2) is deleted and replaced with:

(2) Subsection (1) does not apply to election signs or election advertisements.

(c) in Schedule A - Fines, by deleting:

65(2) Improper election sign \$250

11. Bylaw 19394, Tax Penalty, Interest and Monthly Payment Bylaw, section 18(b) is amended by deleting and replacing “Initial Payment” with “Initial Installment”.

12. Bylaw 20363, Waste Services Bylaw, is amended by inserting section 33(1)(b.1) following section 33(1)(b):

(b.1) is located at least 1.5 metres from any fire hydrant

13. Bylaw 18548, Tax and Assessment Electronic Communication and Web Portal Charter Bylaw, is revised as follows:

(a) by deleting and replacing the title of the bylaw with “Revised Charter Bylaw 18548, Tax and Assessment Electronic Communication and Web Portal Bylaw”;

(b) section 2(j) is deleted; and

(c) in section 6(3), by deleting and replacing “FOIP Act” with “*Protection of Privacy Act*, SA 2024, c P-28.5”.

14. Revised Bylaw 20849, Closure of a portion of the undeveloped 121 Street NW road right-of-way located between 107 Avenue NW and 118 Avenue NW, Queen Mary Park, Westmount, Prince Rupert and Inglewood, is revised by deleting and replacing Attachment 1 with Attachment 1 as set out in Schedule A of this bylaw.
