BYLAW 19165

A Bylaw to amend Bylaw 18343, to authorize the City of Edmonton to construct, finance and assess Decorative Street Lights Local Improvement in the Virginia Park Neighbourhood

WHEREAS:

The Council of the City of Edmonton on April 24, 2018 duly passed Bylaw 18343, authorizing the City of Edmonton to construct, finance and assess the Decorative Street Lights Local Improvement in the Virginia Park Neighbourhood (the “Project”), and also authorizing the Mayor and Chief Administrative Officer to borrow the sum of \$27,224.00, to be paid by a local improvement assessment in the amount per annum for fifteen (15 years);

It has now been determined that the interest rate of the said Project authorized by Bylaw 18343 should be 3.038% and not 3.466%, as provided for in the said bylaw and that the unit rate for the local improvement assessment should be \$0.62 per metre for fifteen (15) years and not \$0.64 per metre per year for fifteen (15) years as provided for in the said bylaw. As a result of the listed changes, it has also now been determined that within the said bylaw the original Schedule “A” be replaced with a revised Schedule “A”;


THEREFORE, THE COUNCIL OF THE CITY OF EDMONTON DULY ASSEMBLED
ENACTS AS FOLLOWS:

1. Bylaw 18343 is amended in the preamble, paragraph six, thereof by deleting the date “December 31, 2016” and the amount of “\$3,338,949,882.41” for the existing debt of the City of Edmonton as it appears and substituting the date “December 31, 2019” and the figure “\$3,202,765,050.41”.
2. The said Bylaw is further amended Section (1), thereof by deleting the figure “\$0.64” as it appears and by substituting the figure “\$0.62”.
3. The said Bylaw is further amended Section (3), thereof by deleting the word “three and four hundred-sixty-six thousandths per cent” as it appears and by replacing with “three and thirty-eight thousandths per cent” and by deleting the figure “3.466%” as it appears and by substituting the figure “3.038%”.
4. The said Bylaw is further amended by replacing Schedule "A" with Schedule "A" as attached.

5. This Bylaw shall take effect on the day of the final passing thereof.
