### VEHICLE FOR HIRE BYLAW AMENDMENT No. 15

## Edmonton City Council enacts:

- Bylaw 14700, the Vehicle for Hire Bylaw, is amended by this bylaw.
- 2 Section 6(1) is deleted and replaced with:
  - 6(1) A person shall not operate, cause or permit the operation of a Taxi, Limited Taxi, Accessible Taxi, Limousine or Shuttle unless the Vehicle Licence issued for the Taxi, Limited Taxi, Accessible Taxi, Limousine or Shuttle is clearly and prominently displayed on the exterior of the vehicle in the manner prescribed by the City Manager.
- Section 6(1.1) is added following section 6(1):
  - 6(1.1) A person shall not operate, cause or permit the operation of a Taxi, Limited Taxi, or Accessible Taxi unless the following information is clearly and prominently displayed on the interior of the vehicle in a form satisfactory to the City Manager and such that it is visible to all passengers:
    - (i) vehicle number;
    - (ii) Vehicle Licence number;
    - (iii) Taxi Broker name and contact information; and
    - (vi) City contact information, as specified by the City Manager.

  - 52 (1) Unless otherwise specified in this section or cancelled pursuant to this bylaw, every Taxi Driver's Licence expires on the second date of birth of the Licensee following the date the Taxi Driver's Licence is issued or renewed.
  - (2) Between January 1, 2014 and December 31, 2014, a Taxi Driver's Licence issued or renewed to a Licensee with an odd year of birth will expire on the date of birth of the Licensee next following the date the Taxi Driver's Licence is issued or renewed.
  - (3) Between January 1, 2014 and December 31, 2014, a Taxi Driver's Licence issued or renewed to a Licensee with an even year of birth will expire on the second date of birth of the Licensee following the date the Taxi Driver's Licence is issued or renewed.
  - (4) Between January 1, 2015 and December 31, 2015, a Taxi Driver's Licence issued or renewed to a Licensee with an odd year of birth will expire on the second date of birth of the Licensee following the date the Taxi Driver's Licence is issued or renewed.
  - (5) A Taxi Driver's Licence may be renewed subject to the provisions of this bylaw.

  - (e) confirmation of a recent, and in any event dated within 90 days of the application, police information check acceptable to the City Manager from the Edmonton Police Service;

  - (3) If a Taxi Driver's Licence is issued or renewed pursuant to section 52(4), the City Manager may waive the requirements of section 53(1)(e).

  - 76(1) Unless otherwise specified in this section or cancelled pursuant to this bylaw, every Limousine Driver's Licence expires on the second date of birth of the Licensee following the date the Limousine Driver's Licence is issued or renewed.
  - (2) Between January 1, 2014 and December 31, 2014, a Limousine Driver's Licence issued or renewed to a Licensee with an odd year of birth will expire on the date of birth of the Licensee next following the date the Limousine Driver's Licence is issued or renewed.
  - (3) Between January 1, 2014 and December 31, 2014, a Limousine Driver's Licence issued or renewed to a Licensee with an even year of birth will expire on the second date of birth of the Licensee following the date the Limousine Driver's Licence is issued or renewed
  - (4) Between January 1, 2015 and December 31, 2015, a Limousine Driver's Licence issued or renewed to a Licensee with an odd year of birth will expire on the second date of birth of the Licensee following the date the Limousine Driver's Licence is issued or renewed.
  - (5) A Limousine Driver's Licence may be renewed subject to the provisions of this bylaw.

  - (2) If, at any time during the term of a Limousine Driver's Licence, any information contained in the police information check required by this section changes, the Licensee must immediately notify the City Manager and provide confirmation of an updated police information check from the Edmonton Police Service.

  - (3) If a Limousine Driver's Licence is issued pursuant to section 76(4), the City Manager may waive the requirements of section 77(1)(f).

  - (g) confirmation of a recent, and in any event dated within 90 days of the application, police information check acceptable to the City Manager from the Edmonton Police Service;
- Section 78(2) is added following section 78(1):
  - (2) If, at any time during the term of a Limousine Driver's Licence, any information contained in the police information check required by this section changes, the Licensee must immediately notify the City Manager and provide confirmation of an updated police information check from the Edmonton Police Service.
- 17 Section 78(3) is added following section 78(2):
  - (3) If a Limousine Driver's Licence is renewed pursuant to section 76(4), the City Manager may waive the requirements of section 78(1)(g).
- 18 Section 94 is deleted and replaced with:
  - 94(1) Unless otherwise specified in this section or cancelled pursuant to this bylaw, every Shuttle Driver's Licence expires on the second date of birth of the Licensee following the date the Shuttle Driver's Licence is issued or renewed
  - (2) Between January 1, 2014 and December 31, 2014, a Shuttle Driver's Licence issued or renewed to a Licensee with an odd year of birth will expire on the date of birth of the Licensee next following the date the Shuttle Driver's Licence is issued or renewed.
  - (3) Between January 1, 2014 and December 31, 2014, a Shuttle Driver's Licence issued or renewed to a Licensee with an even year of birth will expire on the second date of birth of the Licensee following the date the Shuttle Driver's Licence is issued or renewed.

- (4) Between January 1, 2015 and December 31, 2015, a Shuttle Driver's Licence issued or renewed to a Licensee with an odd year of birth will expire on the second date of birth of the Licensee following the date the Shuttle Driver's Licence is issued or renewed.
- (5) A Shuttle Driver's Licence may be renewed subject to the provisions of this bylaw.
