# **Report Summary**

This report introduces and provides background to the new Designing New Neighbourhoods and Complete Streets Policies.

#### Report

Designing New Neighbourhoods and Complete Streets support the development of communities and streets that improve quality of life for Edmontonians. Both projects support the implementation of the Ways Plans by using a flexible design approach rather than a one-size-fits-all standard for the design of future new neighbourhoods in Urban Growth Areas and streets across the city. This will result in new neighbourhoods and streets that are more innovative, adaptive to future changes and challenges, and better integrate transportation and land use.

Designing New Neighbourhoods
The Designing New Neighbourhoods
Policy and the Guidelines for
Edmonton's Future Residential
Communities document have been
prepared to support the development of
innovative and sustainable communities
in Edmonton's Urban Growth Areas.
The Policy and Guidelines implement
policy 4.1.1.1 of the Municipal
Development Plan, The Way We Grow.
They establish a shared vision for future
new neighbourhoods and will inform the
physical structure and lay-out of new
neighbourhoods.

The Policy (Attachment 2) establishes 12 outcomes that will guide planning and design of future neighbourhoods. The Guidelines (Attachment 6) will be used by Administration and other public and private sector city-builders as they work collaboratively to prepare new Neighbourhood Structure Plans. Each outcome is supported by design principles that will be addressed in ways unique to the context of a particular new neighbourhood.

The Policy and Guidelines represent a change in design approach. As such, existing standards, regulations, practices, processes and policies will need to be reviewed and updated over time to realize the creative, innovative, flexible and sustainable design that the

Policy outlines. Change will occur incrementally as new ideas are explored, and as creative and flexible design solutions are implemented.

Implementation of the *Guidelines for Future Residential Communities* (Attachment 6) will require ongoing collaboration between the City, private and public sector partners.

## **Complete Streets**

Complete Streets represents a shift in philosophy to encourage a more holistic approach to roadway design. The intent is to develop a network of roadways that are designed to reflect the characteristics of an area and be safe, attractive, comfortable and welcoming for all users.

The Principles of Complete Streets, established in the Policy (Attachment 3) are the foundation for this shift in design philosophy and provide the direction for developing complete streets in Edmonton. The Principles are not prescriptive and do not dictate any single way of developing a complete street; rather, they will guide the development of creative and innovative streets that reflect the surrounding characteristics and users. Complete Streets Principles seek to find opportunities to most efficiently use the roadway space and they also provide support for innovative development and community revitalization.

Administration has developed *Complete Streets Guidelines* (Attachment 7), which provide guidance on how to implement the Complete Streets Principles. A number of pilot projects will occur over the next year to understand cost implications. Implementation details will be worked out in conjunction with the Urban

Development Institute and other stakeholders prior to commencing use of the Guidelines.

#### **Public Consultation**

The Policies and Guidelines were developed in collaboration with internal and external stakeholders and input from the public (Attachment 1).

Going forward, implementation of both Guidelines will require ongoing consultation, information sharing, collaboration, partnership, and shared decision making amongst city-builders, including: the development industry, community groups, utility companies, school boards, and all areas of the City's Administration.

### Justification of Recommendation

- Approval of the Designing New Neighbourhoods Policy (C572) will establish a vision for future neighbourhoods in Edmonton's Urban Growth Areas and guide the development of innovative and sustainable communities.
- Approval of the Complete Streets
   Policy (C573) will encourage a shift to a more holistic approach to roadway design.
- 3. Receipt of the Guidelines for Edmonton's Future Residential Communities for information will ensure that Administration and public and private city-builders use the Guidelines to implement the shared vision for new neighbourhoods.
- Receipt of the Complete Streets
   Guidelines for information will provide
   Administration with the support to
   develop pilot projects and to refine
   and update the Guidelines over time.
