Community Investment Operating Grant

Program Priorities and Guidelines for 2014-2016

Recommendation:

That Community Services Committee recommend to City Council:

That the 2014–2016 Program Priorities and Guidelines for the Community Investment Operating Grants for not-for-profit organizations, as outlined in Attachment 1 of the May 14, 2013, Community Services Advisory Board report 2013CAAB09, be approved.

Report Summary

This report recommends funding Program Priorities and Guidelines for not-for-profit Social Services, Multicultural and Recreation/Amateur Sport organizations as required every three years in Bylaw 14157 and compares them to the current ones.

Report

- At the April 23, 2013, Community Services Advisory Board meeting, the board approved the recommendations for 2014-2016 Program Priorities and Guidelines outlined in Attachment 1 of the Community Services Advisory Board report 2013CAAB09.
- The Community Investment Operating Grant provides limited operating assistance to not-for-profit organizations whose programs or

activities result in benefits to Edmontonians.

- The Community Investment Grant Bylaw 14157 states: "The Community Services Advisory Board will prepare for the approval of Council three-year funding Program Priorities and Guidelines for not-forprofit organizations (Social Services, Multicultural, and Recreation/Amateur Sport) to access community investment operating grants."
- During the review, Community Services Advisory Board, Edmonton Sport Council, and Edmonton Arts Council provided input.
- The proposed priorities and guidelines provide clarity around eligibility criteria and the expectation that organizations demonstrate good governance and management practises. They align with those in Bylaw 14157 and City Policy C211G.
- In addition to the three-year program priorities and guidelines, applications will be considered using the eligibility criteria and evaluation guidelines contained in Bylaw 14157 and City Policy C211G.

This recommendation supports the requirement in Community Investment Grant Bylaw 14157 that there be a review at the end of each three-year cycle to establish the next three-year funding Program Priorities and Guidelines.

2014-2016 Community Investment Grant – Operating Program Priorities and Guidelines for Social Services, Multicultural, and Recreation/Amateur Sport Organizations

The purpose of providing operating assistance to not-for-profit organizations is to enhance the organizations' ability to provide programs, services or activities that benefit Edmontonians. Grant awards recommendations will be guided by the three-year program priorities and guidelines as well as the criteria and general principles identified in the Community Investment Grant Bylaw 14157 and City Policy C211G.

Program Priorities

Priority will be given to those organizations doing the following:

- 1. Organizations demonstrating sound management practices and good governance (financial, board, and organizational) in carrying out their constitutional objectives.
- Organizations addressing the City of Edmonton's ten-year goal to "Improve Edmonton's livability" by contributing towards goals and objectives in Edmonton's People Plan: The Way We Live.

Guidelines

The following guidelines will be used when considering applicants:

- 1. Organizations may receive one operating grant per year funded by the City of Edmonton. These include operating grant programs for community leagues and seniors' centres, and operating grant programs administered by the Edmonton Arts Council and Edmonton Heritage Council.
- 2. Organizations with a mandate broader than Edmonton may be considered provided that separate financial information is submitted for the Edmonton-based programs and services.
- Organizations that have two years or more of unrestricted cash reserves or restricted but available for operating expenses may not be considered for a operating grant.
- 4. Organizations with eligible operating costs over two million dollars will not normally be considered.

(This guideline will not take effect until 2015.)
