- C477A: Facility Name Sale
 The purpose of this policy is to establish circumstances under which

- C513: Public Involvement

The purpose of this policy is to provide decision makers, the staff of the City of Edmonton, and mostly the citizens and stakeholders that form the public with a consistent and genuine process that will set a standard of excellence for public involvement processes in the city.

- C456A: Corporate Tree Management The purpose of this policy is to protect the tree canopy on City property through the measures set out in the Policy.
- C542: Development Setbacks from River Valley/Ravine Crests
 The purpose of this policy is to ensure and to ensure preservation of the River
 Valley and Ravine System as a significant visual and natural amenity feature,
 contributor to the ecological functionality of the City's natural areas system, and
 recreational opportunity for the citizens of Edmonton.
- C451F: ETS Fare Policy

The purpose of this policy is to provide an opportunity for City Council to direct Administration in implementing a fare structure within the context of an approved fare model and to provide transparency and consistency to citizens regarding the rationale for the setting of transit fares.

• C505:Environment Management System
The purpose of this policy is to establish a corporate Environmental Management
System that will allow the City to employ best available management practices
and due diligence through a variety of measures.

C512: Environmental Policy

The purpose of this policy is to state the City's commitment to environmental sustainability in accordance with the guiding principles stated in the Policy.

C567: Green Building

The purpose of this policy is to establish the application of a Green Building Plan that provides a set of actions aimed at improving the environmental, health, and socioeconomic performance of all types of buildings, existing and new, in the city: commercial, institutional, industrial, mixed-use, multifamily residential and single-family residential buildings.

C466: Integration of Persons with Disabilities

The purpose of this policy is to ensure that the planning, development and provision of civic services to persons with disabilities is in full consideration of their needs and the range of their abilities; and to confirm to citizens that City of Edmonton services are provided on the basis of the principle that every person is equal in dignity and rights and will not be discriminated against with regard to race, religious beliefs, martial status, colour, gender physical disability, mental disability, age, ancestry, place of origin or sexual orientation of that person or of any other person.

C212D: Investment

The purpose of this policy is to establish a set of investment principles and guidelines giving consideration to the type of fund, its characteristics, investment return objectives, financial obligations, the objective of preservation of capital, liquidity, a prudent level of risk given the investment time horizon, while at the same time ensuring that the City of Edmonton's investments comply with statutory requirements.

C511: Land Development Policy

The purpose of this policy is to actively promote initiatives in evolving areas of sustainability, revitalization, and urban form and to ensure an ongoing supply of lot availability to the general public and independent small builders. The policy also sets out that providing opportunities for affordable and/or innovative housing remains a priority for the City.

- C515: Oil and Gas Facilities (note: see setback requirements)
 The purpose of this policy is to: ensure the orderly and safe co-existence of urban development and oil and gas facilities within the City of Edmonton in accordance with the principles set out in the Policy.
- C569: Optimization of the Transportation System Network
 The purpose of this policy is to establish the principles for development of a congestion management framework that considers all modes of transportation to assess the performance of transportation facilities. This provides a consistent approach to planning and design of transportation infrastructure to enable the city to respond to congestion using a multimodal approach that considers the quality of travel by roadway context for pedestrians, cyclists, transit users, auto and goods.

C554: Park and Ride

The purpose of this policy is to provide guidelines regarding park and ride facility location and design; and to provide criteria used to determine parking fees at park and ride facilities.

- C307: Parkland and North Saskatchewan River Valley Utility Installation The purpose of this policy is to reduce City expenditures to restore parkland and River Valley damaged during utility installations by City Utilities, and to eliminate Parks and Recreation expenditures to restore parkland, including the River Valley, damaged during utility installations by non-city agencies.
- C555: Public Private Partnership (P3)

The purpose of this policy is to guide the City's approach to evaluating and pursuing potential P3s. The Policy provides process certainty and clarity for all stakeholders throughout a P3's life cycle by ensuring a consistent framework for selection, evaluation, approval, delivery and monitoring of P3s.

 C532: Sustainable Building Policy—Leadership in Energy and Environmental Design (LEED) Silver

The purpose of this policy is to ensure that City-owned new facilities and major renovations are designed and constructed to an environmentally sustainable standard that benefits all Edmonton residents, now and in the future.

C556: Sustainable Purchasing

This policy applies to the procurement of goods, services and construction by all Departments reporting to the City Manager and the Office of the City Auditor. Full implementation of the policy will be phased in over time.

Supplier Code of Conduct

The Supplier Code of Conduct sets the minimum performance standards for Suppliers and their subcontractors and supports the City of Edmonton's Sustainable Purchasing Policy.

C539: Transit Service Standards

The purpose of this policy is to set service standards that guide the design of the transit system, recognizing customer needs and ensuring the effective use of available resources.

C506: Urban Traffic Noise Policy

The purpose of this policy is to seek to ensure that the negative impacts associated with the ongoing exposure to excessive traffic noise is mitigated in the City of Edmonton and to assign responsibility for traffic noise to developers or the City of Edmonton as required.

 C425: Legal Representation and Indemnification of City Employees, Agents and Members of Council

The purpose of this policy is to provide administrative direction to all concerned on the wishes of City Council on the title subject.

 C559: Liquor Advertising on Edmonton Transit System Equipment and Property

The purpose of this policy is to provide guidelines for liquor advertising on Edmonton Transit System equipment and property.

- C524: Benefit Plan Continuation After Term (Members of Council)

C520B: Municipal Census Policy

The purpose of this policy is to gather current, reliable census data as it is an essential tool available to the City of Edmonton, and all census data consumers, that will enable them to meet current and future challenges. Basing decisions on constantly updated demographics results in more appropriate use of revenue and resources, allowing consumers to be proactive in their response to multiple demands, shifts in priorities and rapid changes that the future will bring.

C561: City Hall Public Space Use

The purpose of this policy is to: provide a fair and reasonable procedure for the use of City Hall space while maintaining the principle of public access to City Hall and providing a safe welcoming environment for all Edmontonians; ensure that as Edmonton's municipal government, an atmosphere that is safe, fair and democratic is maintained; and ensure the majority of non-civic events hosted by Edmonton and area registered not-for-profit organizations are free and open to all citizens. The operating principle of "user pay" for incremental costs is reflected in these procedures.

- C475A: Civic Agencies Appointments
 The purpose of this policy is to regularize the selection and appointment of city representatives to Civic Agencies.
- C476C: Civic Agencies Reporting
 The purpose of this policy is to standardize the reporting of Civic Agencies to City Council.
- C464: Clean-Up of Dangerous Goods
 The purpose of this policy is to ensure that responsibilities and procedures for dealing with the clean-up of Dangerous Goods are clearly identified and understood and to ensure that clean-up costs are appropriately allocated to the responsible party.
- C453: Street Cleaning C.B.D. and Selected Strip Commercial Areas The purpose of this policy is to establish standards for the frequency of street cleaning in the C.B.D. and selected strip commercial areas.
- C471B: Policy for Siting Telecommunications Facilities
 The purpose of this policy is to ensure that telecommunication companies consult with each other regarding proposed sites, that the structures are constructed in a way that is sensitive to the impact on the surrounding community and to ensure adequate public consultation.
- C562: Community Facility Partner Capital Grant Program
 The purpose of this policy is to: enhance support for community facilities by providing funding for the capital development and conservation of public use

facilities in Edmonton; provide City Council with an objective, transparent and consistent method and framework to allocate funding for the conservation and development of public use facilities; and to encourage capital projects that extend beyond City of Edmonton planned service levels and those which maintain or improve public opportunities for recreation and leisure.

- C211F: Community Investment Grants to Organizations and Individuals
 The purpose of this policy is to provide eligibility criteria and evaluation guidelines
 for the awarding of Community Investment Grants to Organizations and
 Individuals.
- C502A: Community League Grants
 The purpose of this policy is to provide limited financial assistance to support the emerging, re-establishment or merging Leagues, the operations of Leagues and the conservation and development of League facilities.
- C417A: Family and Community Support Services Program
 The purpose of this policy is to authorize participation in the Family and
 Community Support Services program and define "Family and Community
 Support Services Program" as the development and/or delivery of preventive
 social services eligible for cost-sharing with the Government of Alberta under the
 terms and conditions of the Family and Community Support Services Act and
 Regulation.
- C479: Fiscal Policy for the Enterprise Portfolio Community Services The purpose of this policy is to formalize the fiscal management and operating principles of the Enterprise Portfolio to ensure long-term viability, growth, stability, and entrepreneurial spirit within the municipal environment.
- C450B: Policy to Encourage the Designation and Rehabilitation of Municipal Historic Resources in Edmonton
 The purpose of this policy is to encourage the designation and conservation of historic resources in Edmonton.
- C518: Council Initiatives
 The purpose of this policy is to provide a governance model for Council
 Initiatives, including the process Council and Administration will follow.
- C530: Council Orientation and Training
 The purpose of this policy is to establish guidelines for Council's orientation to
 ensure Members of Council have an overview of: their roles, responsibilities, and
 duties under the Municipal Government Act; working relationships with
 Administration and the City's governance structure; City bylaws, policies,
 strategic plans, status of City business and current issues facing the City; and a

- C557: Current Planning Branch Revised Business Model The purpose of this policy is to formalize the fiscal management and operating principles of the Current Planning Enterprise Model to ensure long-term viability, growth, and stability within the City of Edmonton.
- C203C: Debt Management Fiscal Policy
 The purpose of this policy is to establish financial guidelines and appropriate controls for the issuance and use of new Debt and to ensure a favourable financial position while supporting the City's ability to meet current and future infrastructure challenges.
- C433D: Determination of Assessable Roadway-Related Local Improvements The purpose of this policy is to provide clear and consistent guidelines regarding the identification of construction to be assessed as roadway-related local improvements.
- C553: Development Fund Program Policy
 The purpose of this policy is to encourage property owners in Enterprise Areas to
 invest in higher density residential and/or retail and commercial development
 through financial incentives to assist in the revitalization of main street
 commercial areas in need of added support.
- C541: Disaster Relief Monetary Donations by the City of Edmonton The purpose of this policy is to state the City of Edmonton's policy on providing monetary relief for disasters outside Edmonton.
- C519: Political Contribution
 The purpose of this policy is to: ensure that the City of Edmonton complies with federal and provincial legislation with respect to political contributions; and provide guidelines with regard to attending political events on behalf of the City of Edmonton.
- C215: Downtown Retail and Commercial Complex Reinvestment Policy The purpose of this policy is to revitalize Downtown Edmonton by encouraging building owners to invest capital in tenant and building improvements that promotes improvements in the appearance of street level businesses and increases business-pedestrian activity. The program should indirectly increase the municipal taxes collected on Downtown properties.

 C304B: Drainage Services Utility Fiscal Policy – Sanitary & Land (Stormwater) Utilities

The purpose of this policy is to ensure that: the Sanitary and Land (Stormwater) Drainage Utilities are operated in a manner that reflects City Council's overall vision and philosophical objectives for the Utilities; there is a consistent approach year over year for the financial planning, budgeting, and rate setting for the City managed Utilities; and the Utilities are financially sustainable over the long term.

- C508: Municipal Emergency Plan
 The purpose of the City of Edmonton's Municipal Emergency Plan (MEP) is to provide a guide to prepare for, and respond to, major emergencies and disasters affecting Edmonton.
- C187A: Enhancing Community Facility Services through Partnerships The purpose of this policy is to establish a framework of principles and procedures to guide developing and ongoing partnership relationships that provide public recreation and leisure opportunities, benefit the community and enhance Community Facility Services to the citizens of Edmonton.
- C216A: Retail and Commercial Façade and Storefront Improvement Program Policy

The purpose of this policy is to encourage owners of Retail and Commercial Buildings in Targeted Areas to invest in improvements that improve the appearance and function of their Building Facades and Storefronts with regard for the interface between public pedestrian space and street oriented retail and commercial activities.

- C200B: Financing of Local Improvements
 The purpose of this policy is to provide clear and consistent guidelines regarding the identification of construction to be assessed as local improvements.
- C167A: Recreation User Fee The purpose of this policy is to provide clear and consistent procedures for establishing user fees for various City of Edmonton operated services, as granted under the Municipal Government Act.
- C523A: Fire Rescue Service Delivery and the Fire Rescue Master Plan The purpose of this policy is to ensure that: alignment with the direction set by City Council in *The Way Ahead*; legislative requirements are met, which include that a Quality Management Plan is in place as required by the *Alberta Safety Codes Act*; and industry standards and benchmarks are met, which include the National Fire Protection Association, and the Commission on Fire Accreditation International. This policy also aims to reflect the expectations of fire rescue services partners, stakeholders and the general public.
- C558: Waste Management Utility Fiscal Policy
 The purpose of this policy is to ensure that: the Waste Management Utility is
 operated in a manner that reflects City Council's overall vision and philosophical

objectives for the Utilities; there is a consistent approach year over year for the financial planning, budgeting, and rate setting for the City managed Utilities; and the Utility is financially sustainable over the long term.

 C468: Policy to Govern the Use of Funds from the Sale of Surplus School Sites

The purpose of this policy is to provide direction as to the use of funds received from the sale of a surplus site.

- C563: Gifts and Honoraria to Council Members
 The purpose of this policy is to establish guidelines for Members of Council in accepting and disclosing gifts and honoraria in the course of fulfilling their duties as elected officials.
- C514: Guidelines for the Implementation of Safety Measures Around Schools The purpose of this policy is to ensure that school areas are reviewed and that appropriate safety measures are considered.
- C435: The Identification and Acquisition of Land for Social Housing The purpose of this policy is to ensure the availability of land for social housing developments in all residential neighbourhoods.
- C444: Human Services Delivery System
 The purpose of this policy is to provide for the efficient and effective delivery of Human Services.
- C529: Immigration and Settlement

The purpose of this policy is to enable the City, within its mandate as municipal government and service provider, to work with all other orders of government; economic, social and cultural institutions; and immigrants to attract newcomers and provide support to enable immigrants to develop a sense of identity, belonging and full participation in the social, economic, cultural and political life of Edmonton.

 C551: Residential Infill in Mature Neighborhoods and the Residential Infill Guidelines

The purpose of this policy is to set planning and design standards intended to assist the City of Edmonton and the development industry in achieving high quality residential infill.

- C501: Integrated Pest Management The purpose of this policy is to minimize the use of pesticides on City property. Where pesticides are required, this policy sets out responsible use in the control of pests.
- C109: Joint Use of Parks and Schools

 The purpose of this policy is to encourage joint and maximum use of public facilities for the greatest possible public benefit.

C516B: Land Enterprise Dividend Policy

The purpose of this policy is to outline a Dividend Payment by the Land Enterprise that will allow it to fund the planned land activities on a self-sustaining basis and provide a return on the City's investment.

 C437: The Lease or Sale of City-Owned Land for Social Housing Development

The purpose of this policy is to facilitate the provision of social housing as a desired end use of City-owned land.

 C482: Legal Representation and Indemnification of City Employees, Agents and Members of Council

The purpose of this policy is to provide administrative direction to all concerned on the wishes of City Council on the title subject.

C474: Lost and Found

The purpose of this policy is to provide a procedure for the disposition of lost or unclaimed property and cash coming into the possession of the municipality which is consistent with section 610 of the M.G.A. and which recognizes, to the extent possible, the legal right of a finder to acquire title to the property or cash as against all but the true owner.

 C509A: Naming Development Areas, Parks, Municipal Facilities, Roads and Honourary Roads

The purpose of this policy is to establish: the role of City Council, Executive Committee, and the Naming Committee for the naming of development areas, parks, municipal facilities, roads and honourary roads; the criteria to recognize and commemorate noteworthy persons whereby the names will be placed on the Names Reserve List; principles for the naming of development areas, parks, municipal facilities, roads, and honourary roads; principles to recognize former Mayors; and principles to recognize former Councillors.

- C534: Outdoor Aquatics and the Outdoor Aquatics Strategy
 The purpose of this policy is to plan a range of outdoor aquatic opportunities for Edmonton.
- C209C: Parking Meter Permits

The purpose of this policy is to: formalize the issuance of parking meter permits by establishing permit types, restrictions, and corresponding annual fee schedules; and ensure that the Mayor, Members of Edmonton City Council, Premier, Lieutenant Governor of Alberta, Provincial Cabinet Ministers, Members of the Legislative Assembly, Members of Parliament representing Edmonton, elected School Trustees representing Edmonton, and the Chief Justice of Alberta may each obtain an unrestricted parking meter permit at no cost.

C415: Postponement of Second Mortgage

The purpose of this policy is to give direction to the Administration on the conditions under which a: postponement of a second mortgage is allowed; transfer of a second mortgage is allowed; and forgiveness agreement can be established with a new purchaser assuming a second mortgage.

 C535: Process for Developed Properties that are Currently Unserviced to Connect to City Services

The purpose of this policy is to provide a clear and consistent process regarding requests to connect to City services from developed properties in the City of Edmonton that are currently unserviced.

C204: Public Works Reserve

The purpose of this policy is to provide the guidelines for the accounting and disposition of the Public Works Reserve.

- C564: Residential Neighbourhood Street Lighting Renewal Policy
 The purpose of this policy is to establish design, construction and equipment
 guidelines and standards intended to assist the City of Edmonton in achieving
 proper residential street lighting in neighbourhood reconstruction projects and
 residential infill projects.
- C543: Retroactive Municipal Tax Refunds

The purpose of this policy is to: guide Council's discretionary power to grant retroactive tax refund for the construction period for properties that become exempt on completion; and ensure requests from non-profit organizations asking for tax refunds for the municipal portion of the property taxes under the Municipal Government Act, R.S.A. 2000, c. M-26 (MGA), Section 347, for the period of time the buildings are under construction and do not qualify for tax exemption, are dealt with in a consistent manner.

- C552: Revolving Commercial Servicing Fund The purpose of this policy is to encourage commercial development through financial incentives.
- C533: Revolving Industrial Servicing Fund The purpose of this policy is to encourage industrial development through financial incentives.
- C550: Roadway Cleaning
 The purpose of this policy is to set spring and summer roadway cleaning standards to provide roadway safety while protecting the environment.
- C436: Site Selection Guidelines for Senior Citizen and Family Social Housing The purpose of this policy is to ensure that social housing sites for senior citizen and family projects are well located in terms of proximity to transportation, shopping, recreational and educational facilities, that there is physical integration of these projects in existing neighbourhoods and that there is minimum distance

from land uses which are potentially hazardous to social housing project residents.

C409G: Snow and Ice Control

The purpose of this policy is to set winter snow and ice control standards to provide for a safe and reliable transportation network while protecting the environment and providing excellent customer/citizen service.

- C438: Social Housing Capital and Operating Subsidy Agreements
 The purpose of this policy is to authorize the provision of social housing for
 individuals and families whose demonstrated need for adequate and affordable
 housing with a reasonable security of tenure cannot be met without government
 or private non-profit agency assistance.
- C566: Speed Reduction Policy

The purpose of this policy is to allow Community Leagues to request that the City undertake a review of speed limits for residential roadways within their community, for consideration of reducing the speed limit on residential roadways within their community to 40 km/hr.

C459: Statuary Policy

The purpose of this policy is to ensure that all statues accommodated on civic property are aesthetically pleasing and have some relevance or value to a large cross-section of the community.

C565: Transit Oriented Development

The purpose of this policy is to establish the application of the Transit Oriented Development Guidelines to provide certainty to citizens, business and administration.

C504: Volunteerism Policy

The purpose of this policy is to: recognize the essential role that Volunteers, Civic Volunteers and Volunteerism play in building a healthy and vibrant Edmonton; recognize the role that Volunteers, Civic Volunteers and Volunteerism contributes in making Edmonton a community of choice for businesses and individuals; and strengthen Volunteerism in Edmonton.

C527: Waste Management

The purpose of this policy is to outline the environmental, economic and social requirements guiding Edmonton's integrated waste management system.
