Report Summary

A total of \$17,370 is recommended in Travel funding to twenty-eight individuals.

- Applications were accepted at the Edmonton Arts Council up to 4:30 p.m., on October 1, 2012.
- Thirty applications were received.
- A Travel Peer Jury was appointed in accordance with Bylaw 14157 Community Investment Grant Bylaw and Policy C211F Community Investment Grants to Organizations and Individuals.
- The Travel Peer Jury considered the applications and made funding

- recommendations to the Edmonton Arts Council Board of Directors.
- The Edmonton Arts Council Board approved the recommendations on November 14, 2012.
- In accordance with Bylaw 14157 and Policy C211F, each applicant was notified of the jury's grant recommendation.
- Twenty-eight grants are recommended.
- There were two applicants that the Jury did not recommend.
- The jury encouraged Edmonton Arts Council staff to follow up with those unsuccessful applicants so they could apply at the next deadline with stronger proposals.
- This is the third and final round of Travel Grants through the Edmonton Arts Council for 2012.
- There are three deadlines scheduled for 2013 – February 1, June 1 and October 1.

Program Summary

Purpose / Eligibility

Residents and non-profit organizations active in the arts and festival communities may apply for this grant, with some restrictions outlined in the guidelines. Funds are intended to support round trip travel from Edmonton to the benefit of both the applicant and the citizens of Edmonton.

Assessment is based on the project's potential benefit for the applicant and for the community, as well as the degree to which the project cannot be undertaken locally. Additionally the applicant's previous record of activity in the sector must demonstrate merit commensurate with receiving public support.

Level of support

Grants in this program are to a usual maximum of \$750 per traveler, and may only be applied towards economical travel costs.
