- The Peer Jury considered the applications and made funding recommendations to the Edmonton Arts Council Board of Directors.
- The Edmonton Arts Council Board approved the recommendations at their November 2012 meeting.
- In accordance with Bylaw 14157 and Policy C211F, each applicant was notified of the jury's grant recommendation.
- Eight grants are recommended.
- The next deadline for applications to this program is May 1, 2013.

# **Community Arts Program Summary**

### <u>Purpose</u>

The Community Arts grant program provides funding for projects that are described as collaborations between professional artists and a distinct community. (A community may be defined by a multitude of factors, including but not limited to: ethnicity, living conditions, geographic location, age, beliefs, traditions, and social or economic strata).

The principles behind Community Art projects are artistic exploration, active participation and intentional inclusiveness that allows communities to tell their own stories. Projects that yield a Public Art outcome by a single artist may be considered in the context of the community's involvement in conceptual development.

### **Eligibility**

Applicants can be individuals or organizations. An individual or organization may apply on behalf of a project involving an ad-hoc group. In such cases the primary applicant must accept responsibility for any funds distributed.

### Level of Support

Grants may be awarded to a normal maximum of \$15,000 and normally in support up to 50% of the expenses of the project
