Daniel Grist	Energy Transition Climate Resilience Committee

<p>Grant Pearsell is an urban planner who helps communities and groups achieve their biodiversity goals. He has lived and worked throughout the Saskatchewan River Watershed since his career in nature conservation began. Grant retired from the City of Edmonton in 2020 where he was a Director and member of City Planning’s leadership team.</p> <p>Grant led the creation and implementation of the City of Edmonton’s biodiversity strategy between 2002 and 2018. His work is guided by a collaborative approach to decision-making and a commitment to integrated systems thinking. Grant directed the creation of the City of Edmonton’s open space plan - Breathe: Edmonton’s Green Network Strategy - winner of the Canadian Institute of Planners Award of Planning Excellence and the Canadian Association of Landscape Architects National Award: Planning and Analysis in 2018.</p>	

Kathleen (Kate) Rich	Energy Transition Climate Resilience Committee
<p>Kate Rich, M.Sc. and P.Geo., has led various strategies for the public and private sectors related to energy, climate change, water and land management – all with a focus on sustainable economic growth. She has worked in several cities across Canada and internationally, and returned to Edmonton and the Government of Alberta in February 2020.</p> <p>She was an Assistant Deputy Minister in the Government of Manitoba leading delivery of the province’s Climate and Green Plan.
