# Edmonton City Council enacts:

- Bylaw 15894, the Safety Codes Permit Bylaw, is amended by this bylaw.
- 2 Schedule A Permit Fees is deleted and replaced wit the attached Schedule A Permit Fees.
- This bylaw comes into force on January 1, 2013.

## **SCHEDULE A - PERMIT FEES**

#### **PART 1 - DEFINITIONS**

- 1. In this Schedule:
  - (a) "Construction Value" means the value of the construction of an undertaking as determined by the City Manager and includes all applicable taxes;
  - (b) "Combination Permit Fee" means a single fee payable for all of the following permits for an undertaking:
    - (i) a building permit,
    - (ii) an electrical permit;
    - (iii) a gas permit,
    - (iv) a heating, ventilating, and air-conditioning permit, and
    - (v) a plumbing permit;
  - (c) "Electrical Installation Cost" means the cost of the materials and labour to install a particular electrical undertaking; and
  - (d) "Floor Area" means the area of the uppermost story having its floor level not more than 2 metres above grade and the story above that, if any, in square feet.

#### **PART 2 – COMBINATION PERMIT FEES**

2. The following Combination Permit Fees are payable in relation to new single detached housing development:

### **PART 3 – BUILDING PERMIT FEES**

3. The following building permit fees are payable for any permits issued for an addition or alteration to an existing single detached housing development:

Construction Value	Building Permit Fee
\$0 - \$5,000	\$100
\$5,001 - \$10,000	\$145
\$10,001 - \$25,000	\$250
\$25,001 - \$50,000	\$465
\$50,001 - \$100,000	\$903
Over \$100,000	\$1,760

- 4. The building permit fee is \$100 for any of the following residential undertakings:
  - (a) an accessory building;
  - (b) an uncovered deck;
  - (c) a hot tub;
  - (d) a swimming pool;
  - (e) a detached garage;
  - (f) a single family house demolition; or
  - (g) a mobile home move on.
- 5. The fee for a building permit for any commercial, industrial, institutional or multifamily development is:
  - (a) \$9.80 for each \$1,000 of Construction Value for the first \$1,000,000; and
  - (b) \$8.80 for each \$1,000 of Construction Value over \$1,000,000; and
  - (c) Not less than \$146.

#### PART 4 - GAS PERMIT FEES

6 (1) The following fees for a gas permit are payable for any development other than those set out in section 7:

Construction Value	Gas Permit Fee
\$0 - \$15,000	\$154 (1 meter set)
\$15,001 - \$500,000	\$227 (1 meter set)
\$500,001 - \$1,000,000	\$304 (1 meter set)
\$1,000,001 - \$5,000,000	\$456 (1 meter set)
Over \$5,000,001	\$757 (1 meter set)

- (2) In addition to the fees for a gas permit set out in this section, an additional fee of \$40 is payable for each additional meter set.
- 7. The permit fee is \$100 for a gas permit in relation to any single detached housing development or any single unit in a residential multi-family development.

#### PART 5 - PLUMBING PERMIT FEES

- 8 (1) The fee for a plumbing permit for any multifamily residential development is:
  - (a) \$100 per unit; and
  - (b) \$100 per sewer connection;

to a maximum of \$190 per building.

- (2) The fee for a plumbing permit in relation to any single detached housing development or any single unit in a residential multi-family development is \$100.
- (3) The fee for a plumbing permit for any other undertaking is \$0.47 for each \$1,000 of Construction Value and not less than of \$154.

# PART 6 – HEATING, VENTING AND AIR CONDITIONING PERMIT FEES

- 9 (1) The fee for a heating, ventilation and air-conditioning permit for any multifamily residential development is \$0.55 for each \$1,000 of Construction Value.
  - (2) The for a heating, ventilation and air-conditioning permit to alter or replace an existing heating, ventilation and air-conditioning system in a multifamily residential development is \$100 for each unit.

- (3) The fee for a heating, ventilation and air-conditioning permit in relation to any single detached housing development or any single unit in a residential multi-family development is \$100.
- (3) The fee for a heating, ventilation and air-conditioning permit for any other undertaking is \$0.55 for each \$1,000 of Construction Value and not less than \$154.

### PART 7 - HOARDING PERMIT FEES

- 10. The fee for a hoarding permit is payable on the first day of each month for each month, or portion thereof, that the hoarding is in place and is calculated as follows:
  - (a) If the hoarding projects from the property line towards a roadway:
    - (i) \$4.78 for each lineal metre of boulevard occupied, plus
    - (ii) \$3.74 per square metre of sidewalk or roadway occupied in the first 2.4 metres from the edge of the sidewalk or roadway, plus
    - (iii) \$14.62 per square metre of sidewalk or roadway occupied beyond 2.4 metres from the edge of the sidewalk or roadway; and
  - (b) If the hoarding projects from the property line towards an alley:
    - (i) \$3.74 per square metre of alley occupied in the first 1.5 metres from the edge of the alley, plus
    - (ii) \$14.62 per square metre of alley occupied beyond 1.5 metres from the edge of the alley.

### PART 8 - ELECTRICAL PERMIT FEES

- 11 (1) An underground service cable permit fee of \$75 is payable for new single detached housing development.
  - (2) The following house wiring permit fees are payable for new single detached housing development:

- 12 (1) An underground service cable permit fee of \$75 per dwelling is payable for new semidetached, duplex or row housing development.
  - (2) A house wiring permit fee of \$200 per dwelling is payable for new semi-detached, duplex or row housing development.
- 13 (1) An underground service cable permit fee of \$162 is payable for new apartment housing development.
  - (2) A house wiring permit fee of \$105 per dwelling is payable for new apartment housing development.
- 14. The owner who resides in a single family residential dwelling must pay the following fees for electrical permits for that dwelling:
  - (a) \$185 for any service changes; and
  - (b) \$135 for any minor alterations.
- 15. The following fees are payable for an annual electrical permit:

\$0 - \$5,000	\$312 for two hours of inspection time, plus \$105 per hour for each additional hour, or portion thereof, of inspection time.
\$5,001 - \$50,000	\$480 plus \$1.60 for each \$100 of Electrical Installation Cost, or portion thereof, over \$5,000.
\$50,001 - \$1,000,000	\$1,206 plus \$1.10 for each \$100 of Electrical Installation Cost, or portion thereof, over \$50,000.
\$1,000,000 - \$3,000,000	\$12,615 plus \$0.75 for each \$100 of Electrical Installation Cost, or portion thereof, over \$1,000,000

Over \$3,000,000	\$28,995 plus \$0.25 for each \$100 of
	Electrical Installation Cost, or portion
	thereof, over \$3,000,000

- 16 (1) The fee payable for an electrical permit for a temporary event will be payable per hour, or portion thereof, of inspection and reporting required, on the following basis:
  - (a) \$135 for the first hour;
  - (b) \$105 for each additional hour; and
  - (c) double those amounts and a minimum charge of \$480 for inspections required before 8 A.M. or after 5 P.M. on weekdays or any inspections on weekends or statutory holidays.
- 17 (1) The following fees are payable for stand alone electrical permits:

\$3,001 - \$10,000	\$61 plus the Electrical Installation Cost multiplied by 0.0247
\$10,001 - \$50,000	\$250 plus the Electrical Installation Cost multiplied by 0.0061
\$50,001 - \$250,000	\$303 plus the Electrical Installation Cost multiplied by 0.0047
Over \$250,000	\$1,034 plus the Electrical Installation Cost multiplied by 0.0021

(2) The following fees are payable for electrical permits obtained in connection with other permits:

\$0 - \$24,000	\$135
\$24,001 - \$80,000	\$61 plus the Construction Value multiplied by 0.0031
\$80,001 - \$400,000	\$250 plus the Construction Value multiplied by 0.0008
\$400,001 - \$2,000,000	\$303 plus the Construction Value multiplied by 0.00061
Over \$2,000,000	\$1,034 plus the Construction Value multiplied by 0.00027

# **PART 9 – ADDITIONAL FEES**

- 18. The fee for any additional inspections to those set out in this bylaw is \$240.
- 19. In addition to the double permit fees payable pursuant to section 21(2) of this bylaw, the fee for any interior alterations to a commercial or industrial building that are commenced without a permit is \$361.
- 20. If a permit is extended or reactivated, the Owner shall pay a fee equal to one-half (1/2) of the amount required for a new permit for such project, provided no changes have been made or proposed to what was originally approved.
