



# Special Transportation and Infrastructure Committee Report

## Downtown LRT Concept Plan – Southeast to West LRT Connection

### *Recommendation of the Committee*

1. That the revisions to the Downtown LRT Concept Plan as outlined in Attachments 7 and 8 of the November 15, 2011, Transportation Services report 2011TS5339rev be approved with the following change:
  - from 95 street to 107 street, routing to be on 103/102A avenue instead of 102 avenue.
2. That Administration bring forward amendments to the Transportation System Bylaw 15101, and any other impacted land use plans and Community Revitalization Levies and conduct consultations and public hearings, as required.

### *History*

- At the January 31, 2012, Special Transportation and Infrastructure Committee meeting, the January 18, 2012, Transportation Services report 2012TS8480 and the November 15, 2011, Transportation Services report 2011TS5339rev were considered together and the Committee heard from S. Rolinger, Duncan & Craig, LLP; A. Kwan and M. Hung, Chinese Benevolent Association of Edmonton; B. Mason, Edmonton Highlands Norwood; M. Aubry and C. Dorsey, Boyle Street Community League; and K. Minaker and D. Koziak, Riverdale Community League.
- At the January 18, 2012, City Council meeting, the following motions were passed:
  1. That a Special Transportation and Infrastructure Committee meeting be held on January 31, 2012, from 9:30 a.m. to 5:30 p.m. in the River Valley Room to deal with the January 18, 2012, Transportation Services report 2012TS8480 and the November 15, 2011, Transportation Services report 2011TS5339rev, and other related matters.
  2. That the January 18, 2012, Transportation Services report 2012TS8480 and the November 15, 2011, Transportation Services report 2011TS5339rev be referred to the January 31, 2012, Special Transportation and Infrastructure Committee meeting.



- At the November 15, 2011, Transportation and Infrastructure Committee meeting, the November 15, 2011, Transportation Services report 2011TS5339rev was referred to City Council without a Committee recommendation.
- At the November 15, 2011, Transportation and Infrastructure Committee meeting, the following motion was passed:  
**Further Transportation Development Options – 102 A Avenue**  
That Administration bring a report to the January 18, 2012, City Council meeting, outlining the following:
  - a) More details regarding transportation oriented development, redevelopment and mixed use potentials for 102 Avenue and 102 A Avenue
  - b) Further details regarding the potential for an LRT stop at 95 Street and Jasper Avenue
  - c) Alternate options for 102 A Avenue/103 Avenue, including details regarding why 102 A Avenue was not used, and implications of any possible changes
