## Report Summary

# EPCOR WATER SERVICES AND WASTEWATER TREATMENT BYLAW 15816

On September 1, 2011, the Utility Committee of Edmonton City Council will hold a public hearing on the proposed EPCOR Water Services and WastewaterTreatment Bylaw 15816. The proposed Bylaw 15816, if approved, will replace EPCOR's Waterworks Bylaw 12585 previously approved by City Council on July 4, 2006.

The purpose of the proposed Bylaw 15816 is to establish rates, fees and charges for water services and wastewater treatment services provided by EPCOR for the period from April 1, 2012 to March 31, 2017. Terms and conditions for water services are also included. The proposed Bylaw 15816 reflects an extension of the performance based regulation for water rates for a third five-year term and will also include wastewater treatment rates.

Currently, wastewater treatment rates and wastewater collection and transmission rates are levied through Bylaw 9675 – Sewers Use Bylaw. Under the proposed Bylaw 15816, effective April 1, 2012, wastewater treatment rates would be levied through the proposed Bylaw 15816.

City Council would like to hear from interested parties regarding the proposed Bylaw 15816. Written submissions should be delivered or mailed to the Office of the City Clerk, (3rd Floor, City Hall, 1 Sir Winston Churchill Square, Edmonton, ABT5J 2R7); faxed (780-496-8175); or emailed (city.clerk@edmonton.ca). Submissions received by August 10, 2011 will receive response at the public hearing. Submissions received subsequently will be received for information.
