Report Summary

This report recommends the awarding of the Community Investment Grant for Hosting to organizations that applied for the March 1, 2011, grant deadline.

Report

- The 2011 Community Investment Hosting Grant program has two deadlines in 2011 - March 1, 2011, and August 30, 2011.
- Attachment 2 provides the formula used to generate the hosting grant recommendations. This formula was approved at the February 27, 2007, Community Services Advisory Board meeting.
- Three Community Investment Hosting Grant applications were received on the March 1, 2011, deadline.

- The recommendation is to fund all three events for a total hosting grant award amount of \$7,306.25.
- Attachment 3 provides an overview of each applicant's request, eligibility and grant award recommendation.
- No hosting grant award appeals were received for the March 2011 deadline.

Policy

- Community Investment Grant Bylaw 14157 delegates the Community Services Advisory Board the authority to review applications from applicants hosting Recreation/Amateur Sport and Multicultural events and make recommendations for grant awards to Community Services Committee and City Council.
- Community Investment Grants to Organizations and Individuals Policy C211F and the Community Investment Hosting Grant Terms of Reference provide the basis for the implementation of the City of Edmonton Community Investment Hosting Grant program.
