Target Setting Process

Recommendation:

That the process with optional Committee dates for the performance measures target setting sessions, as outlined in the April 27, 2011, Finance and Treasury Department report 2011SM4360, be approved.

Report Summary

This report outlines the process and timelines for the approval of the Corporate Performance Measure Targets associated with the goals of Shift Edmonton's Transportation Mode; Transform Edmonton's Urban Form; and Improve Edmonton's Livability.

Previous Council/Committee Action

At the March 24, 2011, Special City Council meeting, the following motion was passed:

- 1. That the target setting information as outlined in the Shift Edmonton's Transportation Mode section (pages 6 to 18) in Attachment 1 of the March 24, 2011, Finance and Treasury Department report 2011SM4730, be referred to Transportation and Public Works Committee (1:30 p.m. time specific) for review and recommendation to City Council on or prior to July 20, 2011.
- That the target setting information as outlined in the Transform Edmonton's Urban Form section (pages 20 to 33) in Attachment 1 of

- the March 24, 2011, Finance and Treasury Department report 2011SM4730, be referred to Executive Committee (1:30 p.m. time specific) for review and recommendation to City Council on or prior to July 20, 2011.
- 3. That the target setting information as outlined in the Improve Edmonton's Livability section (pages 34 to 50) in Attachment 1 of the March 24, 2011, Finance and Treasury Department report 2011SM4730, be referred to Community Services Committee (1:30 p.m. time specific) for review and recommendation to City Council on or prior to July 20, 2011.

Report

Context

At the March 24, 2011, Special City Council meeting, Administration was directed to provide reports to the three Standing Committees, who would then make draft target recommendations to City Council on or prior to July 20, 2011. These reports would be time specific at 1:30 p.m.

This report outlines the process for bringing information to the Standing Committees, the dates and schedules of information to be presented and introduces budget impacts associated with the target setting process.

Two options for schedules have been included in this report to account for the possibility of The Way We Green directional plan approval. If approval on "The Way We Green" direction plan is delayed, the schedule as outlined in Attachment 1 will be followed. If "The Way We Green" directional plan is approved in May 2011, then the

alternate schedule (Attachment 2) will be followed.

Process

Administrative recommended targets and information supporting the targets will be provided via the normal agenda process, to be distributed to all members prior to the committee meetings.

The measures and target information for the goals that do not have approved directional plans will be brought to City Council via the same committee process. Once plans are approved, a schedule similar to that in Attachment 1, will be produced outlining the committees and timeline for working through the target setting process.

The goals that do not currently have approved directional plans, and the expected date for Council review and approval, are as follows:

- The Way We Green (May 2011)
- The Way We Finance (Q4, 2011)
- The Way We Prosper (Q3, 2012)

Once all of the targets for the three approved plans have been reviewed by Committee and recommended to Council for approval, Council will consider all of the recommendations at one meeting on or before July 20, 2011. Those targets that were approved on or before July 20, 2011, by City Council will be incorporated into the Capital and Operating Budgets to be presented to Council in November for final approval.

Capital budget implications will be captured for any three-year targets through the 2012 to 2014 capital budget process and will be included for City

Council's consideration through the capital budget process. City Council deliberations will determine the prioritization of projects and allocate funding accordingly. At this time, the targets will move from approval in principle to final approval.

Where potential operating cost impacts associated with targets are identified, implications for the 2012 operating budget will be identified and final approval sought during operating budget approvals. Potential impacts for 2013 and 2014 will also be identified, but will not be approved as operating budgets are approved on an annual basis.

Corporate Outcomes

This report relates to the Conditions of Success as outlined in the strategic plan, specifically sound management practices and processes.

Justification of Recommendation

Approval of process for Corporate Performance Measure Targets is required in order that Committees of Council can review recommendations and City Council can approve prior to July 20, 2011.
