2011 Sidewalk Reconstruction Local Improvement Levy Reductions (Sherbrooke and Parkallen)

Recommendation:

That Transportation and Public Works Committee recommend to City Council:

That the local improvement tax cancellation amounts for Sherbrooke and Parkallen, as outlined in Attachment 1 of the March 22, 2011, Transportation Department report 2011TD0830, be approved.

Report Summary

This report addresses the tax cancellations for specific properties in Sherbrooke and Parkallen that have been reconstructed within the last 31 years through a 100 percent Local Improvement Levy and are now being replaced through neighbourhood renewal projects.

Previous Committee Action

At the June 15, 2010, Transportation and Public Works Committee meeting, the following motion was passed:

That the June 8, 2010, Transportation Department report 2010TD5590 be received for information.

Report

The tax reduction strategy as outlined in Attachment 1 was based on one and two below:

- Active 100 percent Sidewalk Local Improvement (01 – 20 year):
 - property owners that have sidewalks with an active 100 percent Sidewalk Local Improvement (year 01-20) would receive a 100 percent reduction by exempting the property owner from the new Local Improvement. In this scenario, the property owner would not pay any Local Improvement costs for the sidewalk reconstruction
- Expired 100 percent Sidewalk Local Improvement (greater than 20 years).
 - property owners that have sidewalks that were constructed through a 100 percent resident funded Local Improvement within the last 30 years
 - are located in neighbourhoods that are identified for reconstruction in the next five years
 - the sidewalk Local Improvement (21+ years) has expired

Those properties, should receive a pro-rated reduction on years 21 to 30 on a sliding scale. In this scenario, the property owner would pay between 0 percent and 50 percent of the new sidewalk cost.

For the 2010/2011 Neighbourhood Renewal Project, there are two neighbourhoods; Sherbrooke and Parkallen, that have properties with sidewalks that were reconstructed within the last 31 years through a Local Improvement Levy that are now being replaced through neighbourhood renewal projects.

2011 Sidewalk Reconstruction Local Improvement Levy Reductions (Sherbrooke and Parkallen)

A portion of the property owners in the Sherbrooke neighbourhood were assessed 100 percent of the cost of Sidewalk Local Improvement charges commencing in 1983. The Sherbrooke neighbourhood sidewalks were replaced by neighbourhood renewal projects in 2010.

The affected Sherbrooke property owners would fall under the expired 100 percent sidewalk Local Improvement option.

If the recommended tax cancellations for Sherbrooke (Attachment 1) are approved by Council, the discount rate for the affected Sherbrooke property owners will be 30 percent.

A portion of property owners in the Parkallen neighbourhood were assessed 100 percent of the cost of Sidewalk Local Improvement charges commencing in 1986. The Parkallen neighbourhood sidewalks were replaced by neighbourhood renewal projects in 2010.

The affected Parkallen property owners would fall under the expired 100 percent sidewalk Local Improvement option.

If the recommended tax cancellation for Parkallen is approved by Council, the discount rate for the affected Parkallen property owners will be 60 percent.

Policy

Budget/Financial Implications

- City funding for these tax cancellations will come from the Neighbourhood Renewal Program.
- Taxes are in the amount of \$19,089.22 (in total) for the identified Sherbrooke tax rolls and \$13,032.10 (in total) for the identified Parkallen tax rolls.

Legal Implications

Pursuant to section 347 of the *Municipal Government Act*, R.S.A. 2000, c. M-26 (MGA), City Council has the ability to cancel or refund all or part of a tax, if it considers it equitable to do so. City Council may only do so with respect to specific taxable properties or a class of taxable properties or businesses.

Justification of Recommendation

The local improvement tax cancellation recommendation applies only to specific properties for sidewalks that have been fully reconstructed within the last 31 years. These sidewalks have been paid for through a 100 percent Local Improvement levy in that time period and are now being replaced through neighbourhood renewal projects.
