

Appointment of 2011 Board of Directors to the Business Revitalization Zones of Edmonton

Recommendation:

That the individuals named in Attachment 1 of the December 10, 2010, Planning and Development Department report 2010PPP127, as the Board of Directors for the Alberta Avenue; Beverly; Chinatown and Little Italy; Downtown; Fort Road; Inglewood; Kingsway; Northwest Industrial; North Edge; Old Strathcona; Stony Plain Road and Area; and 124 Street and Area Business Associations, be appointed for the terms of January 1, 2011, to December 31, 2011.

Report Summary

Council approval of the 2011 Board of Directors for these 12 Business Revitalization Zone Associations is requested to ensure transition and continuity of Business Revitalization Zone related activities into 2011.

Report

The Bylaws that establish these Business Revitalization Zone Associations require Council to annually appoint qualified individuals to serve on their respective Board of Directors.

Individuals are qualified to be a Business Revitalization Zone Board of Director if they have been nominated by a Business Revitalization Zone taxpayer within the business revitalization zone and have consented to act as Directors.

Each of the 12 Business Revitalization Zone Associations has held its respective annual general meeting where one of the tasks is to seek and review nominations for its 2011 Board of Directors.

This recommended slate of Directors is now ready for City Council approval.

Justification of Recommendation

The requests for the appointment of the 2011 Board of Directors for the 12 Business Revitalization Zone Associations comply with provincial and municipal requirements for ongoing management of Business Revitalization Zones in Edmonton.
