Boyle Renaissance Young Men's Christian Association (YMCA) of Edmonton's Welcome Village

Phase One Funding

Recommendations:

- That payment of \$3,000,000 to the YMCA of Edmonton as the First Phase Funding for the YMCA Welcome Village in the Boyle Renaissance Community Hub be approved.
- 2. That the agreement between the City of Edmonton and the YMCA be acceptable in form and content to the City Manager.

Report Summary

This report recommends that the City provide \$3,000,000 to the YMCA Edmonton for Phase One funding for the YMCA Welcome Village, and that the City sign a related agreement with the YMCA Edmonton in a form and content satisfactory to the City Manager.

Previous Council/Committee Action

At the November 9, 2010, City Council meeting, the following motion was passed:

 That amendments to the 2010-2011 Capital Budget as outlined in Attachment 2 of the November 9, 2010, Finance and Treasury Department report 2010FTB008 be approved.

Report

The 2010-2011 Supplemental Capital Budget Adjustment approved by Council November 9, 2010, included Attachment 2 that incorporated a list of projects. Reference No. 2.1A of Attachment 2 includes \$3,000,000 of Pay-As-You-Go funding (formerly General Financing) to fund an increased grant contribution to the YMCA.

YMCA Welcome Village is a vital component of the Boyle-Renaissance Community Hub. Due to the withdrawal of a funding partner, the project encountered financial difficulties. In order to allow the project to proceed, Council included \$3,000,000 in funding in its 2010–2011 capital projects list.

Corporate Outcomes

The information in this report relates to policy 3.4.4.1 of *The Way We Grow* that relates to creation of mixed-use, transit and pedestrian-oriented developments and states:

 "Enhance Downtown liveability by increasing amenities to support the emergence of a highly desirable urban community."

Budget/Financial Implications

Funding was approved by City Council on November 9, 2010, as part of the 2010-2011 Supplemental Capital Budget Adjustment.

Legal Implications

Law Branch is currently working with lawyers for the Boyle Renaissance Development Association for a Master Agreement relating to Phase One.
