AMENDMENT TO RESERVE DESIGNATION BYLAW 15248

Whereas, pursuant to section 665 (1) of the Municipal Government Act, Council may pass bylaws designating parcels of land it owns as municipal reserve, school reserve or municipal and school reserve:

PART 1 - PURPOSE, DEFINITIONS AND INTERPRETATION

PURPOSE

1) This bylaw amends Reserve Designation Bylaw 15248 by adding additional direction that enables registration with Alberta Land Titles Office.

PART 2 – AMENDING CLAUSES

CLAUSES TO BE DELETED/ADDED

- 2) That clauses 2.4, 2.9, 2.12, 2.13, and 2.18 in Bylaw 15248 are hereby deleted in their entirety and replaced with the following clauses:
 - 2.4 Lot 4, Block 60, Plan 082-0372, and Lot 8, Block 60, Plan 0928271, and Lot 24, Block 36, Plan 932-1715, and Lot 30, Block 34, Plan 932-3171 (Hollick-Kenyon neighbourhood)
 - 2.9 Lot B, Plan 892-1511, to be designated as Lot 1MR (Jamieson Place neighbourhood)
 - 2.12 Lot E, Plan 2636MC, to be designated as Lot 4MR, Plan 2636MC; and Lot F, Plan 7219KS, to be designated as Lot 5MR, Plan 7219KS; and closed portion of Road Plan 1733EO abutting the south boundary of Lot F, Plan 7219KS to be designated as Lot 6MR, Plan 1733EO; and Lot J, Block 11, Plan 2741MC, to be designated as Lot 27MR, Block 11, Plan 2741MC (West Meadowlark Park neighbourhood)

- 2.13 Lot 31A and Lot 38, Block 29, Plan 787TR be designated respectively as Lot 31MR and Lot 38MR, Block 29, Plan 787TR (Brander Gardens neighbourhood)
- 2.18 Lot A, Block 11, Plan 022-4576 to be designated as Lot 60MR, Block 11, Plan 022-4576 (Blackmud Creek neighbourhood)
