# **Report Summary**

In accordance with the North
Saskatchewan River Valley Area
Redevelopment Plan, Council
approval is requested for the
Environmental Impact Assessment
and Site Location Study of the
Capitol Theatre development of major
facilities; and that the location be
deemed essential.

#### **Previous Council/Committee Action**

At the May 12, 2010, City Council meeting, the following motion was passed:

That the Fort Edmonton Park 2010 Master Plan update, as outlined in Attachment 1 of the March 24, 2010, Community Services Department report 2010CSR005, be approved.

#### Report

As required by the North Saskatchewan River Valley Area Redevelopment Plan, a Site Location Study and

Environmental Site Assessment were prepared to support the Capitol Theatre development at Fort Edmonton Park. The study and assessment reviewed the cost, social, environmental and institutional constraints that make Fort Edmonton Park the essential location for the Capitol Theatre:

- Cost the redevelopment of the facility in the existing location avoids the capital and operating costs associated with relocation to an external site.
- Social the recreation of the Capitol Theatre contributes to the continuation of Fort Edmonton Park's legacy within the community and the River Valley by enhancing the park's vitality. Completion of the Capitol Theatre will realize the next priority project specified in the Fort Edmonton Park Master Plan.
- Environmental the project site is not within an environmentally sensitive area, as it is outside the flood risk zone, in a geologically stable area, and is within a previously disturbed site.
- Institutional the Capitol Theatre is an essential component in order to realize the Fort Edmonton Park Master Plan vision for the 1920's Street.

## **Policy**

North Saskatchewan River Valley Area Redevelopment Plan, section 3.5, Major Facility and Natural Resource Development Policies.

#### **Focus Area**

- Improve Edmonton's livability
- Transform Edmonton's urban form

## **Public Consultation**

Extensive public consultation was conducted for the Fort Edmonton Park Master Plan May 2010 update, with significant focus on the Capitol Theatre. Further public notification has been implemented, specifically for the Capitol Theatre project. Suggestions for the Capitol Theatre raised through consultation were responded to through the Master Plan update of May 2010. Overall consultation feedback has been supportive for the Capitol Theatre development

# **Legal Implications**

The North Saskatchewan River Valley Area Redevelopment Plan Bylaw 7188 requires City Council to approve an environmental impact assessment and a detailed site location study detailing costs and the social, environmental and institutional constraints that make a River Valley location essential before development of this project may proceed. Further, the Bylaw requires City Council to deem the location within the River Valley to be essential and to approve it before this project may be constructed.

#### Justification of Recommendation

- Approval of the Environmental Impact Assessment and Site Location Study is required to meet the City of Edmonton's North Saskatchewan River Valley Area Redevelopment Plan policy.
- In accordance with the North Saskatchewan River Valley Area Redevelopment Plan, this site must be deemed essential in order to proceed with the project.
