# **Bylaw 15469**

Amendment to Transportation
System Bylaw 15101 to include
Surface Downtown Section of LRT

#### **Purpose**

To include the Surface Downtown Section of LRT, as well as minor changes to the arterial roadway network.

# Readings

Bylaw 15469 is ready for three readings after the public hearing has been held.

This Bylaw is authorized under the Highways Development and Protection Act. A majority vote of City Council on all three readings is required for passage.

The Bylaw does not come into effect until approval of the Minister of Transportation for Alberta is received.

#### **Advertising and Signing**

This Bylaw was advertised in the Edmonton Journal on Friday, June 4, 2010, and Sunday, June 13, 2010.

#### **Position of Administration**

Administration supports this Bylaw.

# **Report Summary**

This report provides an overview of the amendments to Transportation System Bylaw 15101, approved by City Council on December 15, 2009. The Bylaw was completed in accordance with the Transportation Master Plan. Amendments include the proposed Surface Downtown Section of LRT and revisions to the physical description of

Arterial Roadways to align with the Capital City Downtown Plan. Also included is a future roadway in Heritage Valley.

#### **Previous Council/Committee Action**

At the December 15, 2009, City Council Public Hearing, Transportation System Bylaw 15101 received third reading.

## Report

- Transportation System Bylaw 15101
  was completed in accordance with
  the City's Transportation Master
  Plan: The Way We Move, which
  provides direction for city-wide LRT.
  LRT routes that have been planned
  and approved by City Council are
  identified within this Bylaw.
- The Downtown Section of the LRT alignment connecting the West Line and Southeast Lines was not included within Bylaw 15101. The planning work for that section of LRT has now been completed in conjunction with the Capital City Downtown Plan Review and is included within this Bylaw amendment.
- The Surface Downtown Section connects to the West Line at 104 Avenue – 109 Street, running east on 104 Avenue to 107 Street, then south on 107 Street to 102 Avenue and east on 102 Avenue to approximately 95 Street, where the line connects to the Southeast Line.
- The Surface Downtown Section also serves the Government Centre area, running south on 107 Street from 102 Avenue to 99 Avenue, then west on 99 Avenue to 109 Street. Further planning will be required to determine the routing of the central area circulation section of the wider

LRT network. LRT routing south of 99 Avenue will be conducted in cooperation with the Province of Alberta to examine options for LRT in consideration of the potential High Speed Rail, including a multi-modal (LRT/HSR) facility in the vicinity of 109 Street.

- Attachment 2 illustrates the proposed LRT routing in the Downtown. Attachment 3 outlines the analysis process and recommendation for this routing.
- Some roadways within the
   Downtown have been reclassified to
   be consistent with the policy
   direction of the Capital City
   Downtown Plan. Within the
   Downtown, 102 Avenue,
   103 Avenue, and 106 Street are
   removed as arterial roadways. In
   addition, a future arterial roadway
   within Heritage Valley has been
   identified. Attachment 4 summarizes
   the proposed changes to
   Transportation System Bylaw
   Appendix B: Physical Description of
   Arterial Roadways.

### **Policy**

Transportation System Bylaw 15101 and this amendment are prepared in accordance with the *Highways Development and Protection Act* and reflect the recently approved Transportation Master Plan.

#### **Public Consultation**

In accordance with City Policy C513, the Transportation Department conducted comprehensive public consultation throughout the development of the Transportation Master Plan and through the LRT route corridor studies. A summary is provided in Attachment 5

# **Budget/Financial Implications**

Implementation of the proposed transportation facilities outlined in the Transportation System Bylaw will be considered by City Council as part of future capital budget processes.

## Legal Implications
