BYLAW 19048

A Bylaw to amend Bylaw 14481, to authorize the City of Edmonton to undertake, construct, and finance Asset Management and Public Works, Parks Branch Project, Neighbourhood/District Park Development

WHEREAS:

The Council of the City of Edmonton on March 20, 2007 duly passed Bylaw 14481, authorizing the City of Edmonton to undertake, construct, and finance Asset Management and Public Works, Parks Branch Project, Neighbourhood/District Park Development ("Project"), and also authorizing the Mayor and Chief Administrative Officer to borrow the sum of \$8,238,000.00 for a period of fifteen (15) years with the principal and interest to be repaid in semi-annual or annual instalments;

It has now been determined that the Project, 07-28-5210 Neighbourhood/District Park Development, is completed with a total cost of \$2,435,280.00. The borrowing authority will therefore be decreased by \$6,306,636.00 from \$8,238,000.00 to \$1,931,364.00;

THEREFORE, THE COUNCIL OF THE CITY OF EDMONTON DULY ASSEMBLED ENACTS AS FOLLOWS:

1. Bylaw 14481 is amended in the preamble, paragraph two, thereof by deleting the figure "\$8,238,000.00" as it appears and by substituting the figure "\$2,435,280.00".

2. The said Bylaw is further amended in the preamble, paragraph four and Sections (1) and (2), thereof by deleting the figure "\$8,238,000.00" as it appears and by substituting the figure "\$1,931,364.00".

- 3. The said Bylaw is further amended in the preamble, paragraph seven, thereof by deleting the date "December 31, 2005" and the amount of "\$855,000,175.51" for the existing debt of the City of Edmonton as it appears and substituting the date "December 31, 2018" and the figure "\$3,046,193,851.11".
- 4. The said Bylaw is further amended by adding Schedule "A" as attached.
- 5. This Bylaw shall take effect on the day of the final passing thereof.
