## **Nomenclature Development**

Naming Committee | Overview of engagement and introduction of names

- iyiniw iskwewak wihtwâwin (*Indigenous women's involvement/action*)
  - 17 Indigenous female knowledge keepers
  - Elders, Knowledge Keepers, Educators and Descendants within their respective First Nations, Inuit, and Métis Nations
  - Naming Committee Chair and three other committee members joined as ex-officio (non-voting) members to listen, learn, and support
- Guiding Values
  - Indigenous language terms that reflect places, history, flora, and fauna
  - Acknowledge Treaty 6 bands that historically experienced land surrenders in the Edmonton area
  - Recognize the LGBTQ2S+ community
- Ceremony and meetings
  - Chosen names were guided through ceremony
  - Weekly meetings and a weekend retreat on August 8-9
  - Gifted the Names to the Naming Committee on August 27
  - Consensus with respect to one another



- If approved, Bylaw 19366 will come into effect on October 18, 2021
