The following table shares the resolution voting decisions occurring at Alberta Urban Municipalities Association's annual convention on Thursday, September 24, 2020.

The resolutions include four City of Edmonton* sponsored Category B resolutions, which are issues related to AUMA's strategic initiatives. Category C resolutions include any other issues of potential interest to Alberta municipalities. Category E are emergent resolutions that deal with an issue of concern to Alberta municipalities which has arisen after the resolution deadline and must receive a 2/3 majority of votes cast to be considered at the resolutions session prior to debating the merits.
