Edmonton Research Park Leases and Subleases

Leases

There are 5 land leases at the Research Park in which the City leases an entire parcel of land to EEDC. For each of these 5 leases, described under numbers 1 to 5 below, EEDC then subleases the land to a subtenant for development. There is a commercial lease for the Advanced Technology Centre Building (the "ATC Building") in which the City leases the ATC Building to EEDC, described under number 6 below. EEDC then subleases portions of the ATC Building to subtenants.

The Surrender Agreement contemplates a surrender of EEDC's interest in all 6 of these Leases and an assignment to the City of EEDC's interest in all of the Subleases.
