

COVID-19 Update Edmonton Health Zone Data

Total Cases to Date	13,993	20,711	32,550
Active cases	3,572	6,444	9,464
New cases	393	519	943
Hospitalizations	132	191	371
ICU	30	47	72
Infection Rate per 100,000	256.6	496.4	755.2

 - Salvation Army
 - Urban Manor

New Provincial Restrictions - Implications

Private Residences

• only household members are permitted in private homes; individuals living alone may designate 2 visitors

Indoor/Outdoor Gatherings

- social gatherings limited to household members only
- funerals & wedding ceremonies are still limited to 10 in-person attendees, must follow health guidelines. Receptions still not permitted

Places of Worship

maximum 15% of fire code capacity

Retail

- maximum 15% of fire code capacity
- malls open, but seating areas, including food court seating, closed

Working From Home

 mandatory, unless employer determines that employee's physical presence is required for operational effectiveness

Edmonton

Masks

 mandatory in all indoor public places including workplaces and common areas of multi-family residential buildings

New Provincial Closures - Implications

Recreation Facilities

- fitness centres, arenas, pools, gyms closed
- outdoor rinks/ski hills/toboggan hills/dog parks open, subject to gathering prohibitions and distancing requirements

Entertainment

- casinos, bingo halls, museums, libraries, theatres, nightclubs, conference centres, community centres closed
- drive in 'events' where attendees do not leave vehicles are permitted

Restaurants, Bars, Pubs, Cafes

- closed for in-person dining
- takeout, delivery, curbside pickup open

Personal Wellness Services

massage, esthetics, hairstyling, tanning salons closed



Enforcement and Monitoring

We will be supporting the enforcement and monitoring to compliance in the following instances:

- Dog Parks
- Ice Rinks
- Valley Zoo



Working from Home

- Effective December 13, working from home is mandatory unless the employer requires a physical presence for operational effectiveness
- In March, the City of Edmonton implemented a temporary work from home arrangement to protect employees and the public from the spread of COVID-19
