THE CITY OF EDMONTON BYLAW 19406 WASTE SERVICES BYLAW Amendment No. 3

Edmonton City Council enacts:

- 1. Bylaw 18590, Waste Services Bylaw, is amended by this bylaw.
- 2. Section 11(5) is added following section 11(4):
 - (5) The City Manager may establish and charge fees for waste disposed of at City Waste Facilities.
- 3. Section 15(3) is deleted and replaced with:
 - (3) An owner of a residential premises that has not been provided with either a garbage bin or a blue bin:
 - (a) must source separate recyclable materials and may set out recyclable materials for collection in a blue bag;
 - (b) may place cardboard under or next to a blue bag for collection, provided that no individual piece of cardboard exceeds 1.2 metres in length or 0.75 metres in diameter and the total weight of all cardboard placed under or next to a blue bag does not exceed 20 kilograms.
- 4. Section 24(1) is amended by deleting and replacing "collection services provided to" with "collection, processing, and disposal services provided to, or made available to,".
- 5. Section 50 is added following section 49:

ANNEXATION IMPLEMENTATION

The City Manager may approve exemptions or modifications to this bylaw, including the power to waive fees, where such exemptions or modifications are

consistent with inter-municipal negotiations resulting in Order in Council 359/2018.

6. Schedule C is amended by adding the following after "provided to a residential premises.":

In the event that a residential premises has not received a cart or bin from the City Manager on October 1, 2021, that residential premises shall be charged the Residential Curbside (240L Garbage Cart) Monthly Waste Utility Rate until the City Manager provides that residential premises a cart or bin.

7. Schedule C, Table 1 is deleted and replaced with:

- 9. Schedule C is amended by deleting and replacing "Beginning on the day that Waste Services Bylaw 18590 comes into effect" with "Beginning on September 10, 2019".
- 10. This bylaw comes into force on January 1, 2021.
