Province	Municipality	Approach Notices under Section 606 can be advertised as follows:
AB	Airdrie	<ul style="list-style-type: none"> ● published in local newspaper and ● publishing on the municipal website and ● referring interested parties to the municipal website and ● hardcopies made available at City Hall for viewing by the public
AB	Barons	<ul style="list-style-type: none"> ● Posted to municipal website and/or ● posted on official municipal social media sites and/or ● posted on bulletin board at the Village Administrative Office and/or ● by posting the notice prominently on the Village Administrative Office window and/or the bulletin board at the Canada Post Office
AB	Edgerton	<ul style="list-style-type: none"> ● posted to municipal website and ● posted on official municipal social media sites
AB	Gibbons	<ul style="list-style-type: none"> ● published in local newspaper and at least one of the following <ul style="list-style-type: none"> ○ posted to municipal website ○ posted on municipal Facebook site ○ posted on electronic signs located at Gibbons Culture Centre and Centre Park ○ advertisement in Town of Gibbons newsletter published monthly and included in the Water Utility billing
AB	Morinville	<ul style="list-style-type: none"> ● posted to municipal website and/or ● posted on official municipal social media sites and/or ● posted on Town of Morinville' television screens and/or ● posted on local media outlet and/or their social media sites
AB	Nanton	<ul style="list-style-type: none"> ● posted to municipal website and/or ● posted on official municipal social media sites and/or ● posted on bulletin board at the Town of Nanton administrative office and/or ● posted roadside digital board located at both highway entrances to the town
AB	Smoky Lake	<ul style="list-style-type: none"> ● published in local newspaper and ● posted to municipal website

BC	All BC municipalities except Vancouver	<ul style="list-style-type: none"> ● posted in public notice posting places and ● published in a newspaper unless ● this is not practicable, the notice may be given in the areas by alternative means as long as the notice <ul style="list-style-type: none"> ○ is given within the same time period as required for publication, ○ is given with the same frequency as required for publication, and ○ provides notice that the council considers is reasonably equivalent to that which would be provided by newspaper publication if it were practicable. ● Council may provide any additional notice respecting a matter that it considers appropriate, including by the Internet or other electronic means.
BC	Vancouver	<ul style="list-style-type: none"> ● published in newspaper unless ● this is not practicable, the notice may be given in the areas by alternative means as long as the notice <ul style="list-style-type: none"> ○ is given within the same time period as required for publication, ○ is given with the same frequency as required for publication, and ○ provides notice that the council considers is reasonably equivalent to that which would be provided by newspaper publication if it were practicable ● as an exception, this does not apply if the alternative means is by individual distribution to the persons resident in the area. ● Council may provide any additional notice respecting a matter that it considers appropriate, including by the Internet or other electronic means.
ON	Toronto	<ul style="list-style-type: none"> ● posted on the notices page of the municipal website and if ● it is the opinion of the City Clerk and the General Manager, Executive Director or other City official concerned with the matter, the City Clerk is authorized to give notice to the public in an extended manner ● at least once a year, the City Clerk shall cause a notice to be published in a newspaper of general circulation setting out information on how to access the City's Web site to locate public notices and the related City documents; for example, a report or by-law
QC	Hampstead	<ul style="list-style-type: none"> ● posted on the notices page of the municipal website and ● posted on a board in Town Hall and if ● necessary and for any reason deemed valid by the Town, a public notice may also be published in a local newspaper

Note: Canadian municipalities are governed by the distinct legislative frameworks respective to their province.
