Subject: **Council and Committee Meeting Statistics**

Open Data

As part of the commitment to open government, the following information regarding Council and Committee meetings is available on Open Data based on the approved minutes:

- a. [Meeting](#): This dataset includes meeting type, date, time, and location.
- b. [Attendance](#): This dataset shows whether a Councillor was present for a meeting.¹ In SIRE, this was only recorded for a body of which they were a member.
- c. [Agenda items](#): This dataset includes all items on agendas, including category headers (e.g. Call to Order, Reports, Motions Pending).
- d. [Motions](#): This dataset includes all motions, the mover and seconder, and whether each was carried or failed.
- e. [Voting](#): This dataset includes each Councillor's vote on each item.²

Additional Meeting Information

To supplement the statistics in Open Data, the Office of the City Clerk collects additional information. A quick summary of data from the last five years follows.

¹ In SIRE, this was only recorded for a body of which they were a member. eSCRIBE records whether a Councillor was absent or present at a meeting and does not differentiate whether they were required to be present (i.e., whether they are a voting member of the committee). This may require some filtering, coding, or other changes to what is displayed in Open Data.

² Note that information from SIRE included 'absent' as a vote, but in eSCRIBE absent votes show up as omissions.
