A Bylaw to amend Bylaw 12800, as amended,
The Edmonton Zoning Bylaw
Amendment No. 2802

WHEREAS lands shown on Schedule "A" and legally described on Schedule "B"; generally located between 105 Avenue NW and 106 Avenue NW and between 101 Street NW and 106 Street NW, Central McDougall, Edmonton, Alberta, are specified on the Zoning Map as (DC1) Direct Development Control Provision; and

WHEREAS an application was made to rezone the above described property to (DC1) Direct Development Control Provision;

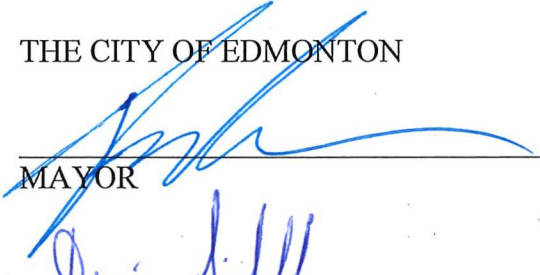

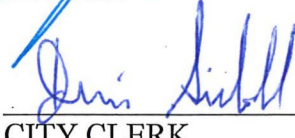

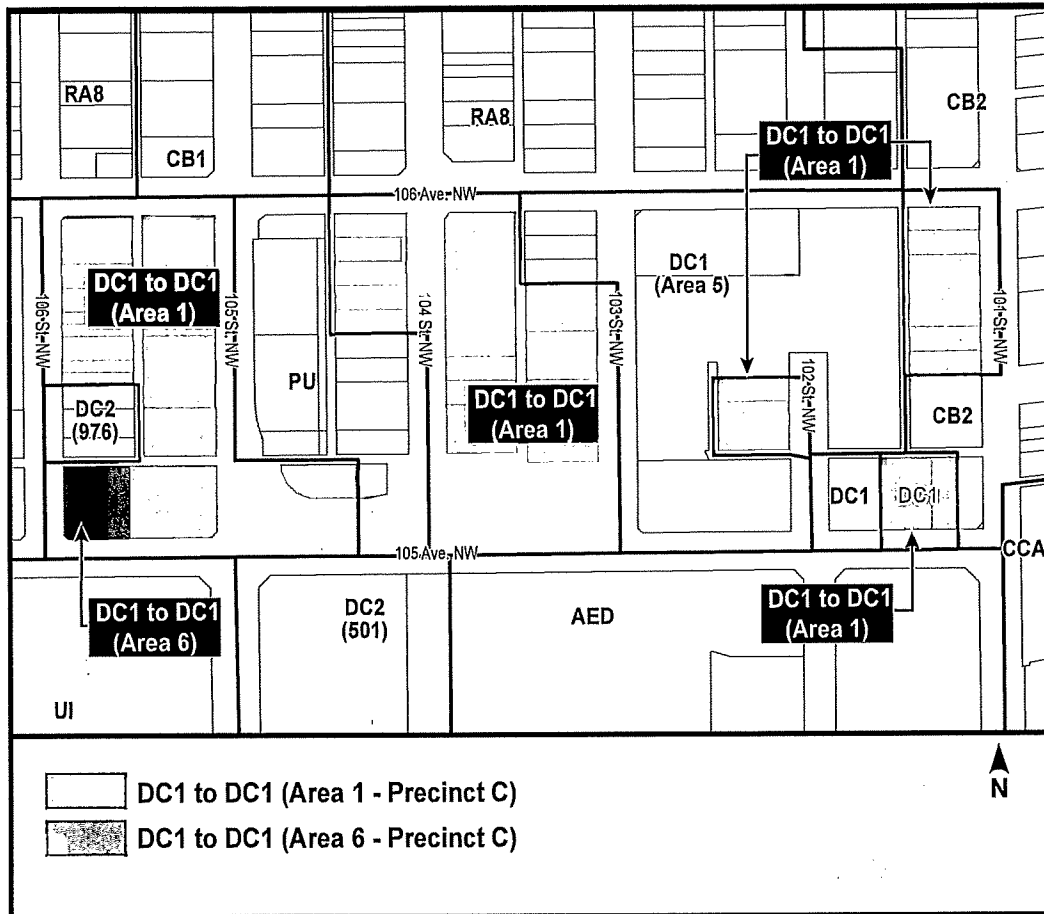
