Executive Summary

This report provides an overview of the operational initiatives planned for the 2021 calendar year for the Water Services and Drainage Services business units of EPCOR Water Services Inc., as outlined in the 2021 Annual Operational Plan provided by EPCOR Water Services Inc.

Report

As part of the ongoing monitoring and reporting of the water, wastewater treatment, and drainage services provided by EPCOR Water Services Inc. (EWSI) under performance based regulation, EWSI presents an Annual Operational Plan to Utility Committee in the first quarter of each year. Attachment 1 contains an overview of the various operational initiatives EWSI has planned for 2021 for the Water Services (includes water treatment and distribution and wastewater treatment) and Drainage Services business units. EWSI notes that a significant number of the initiatives are common to both the Water and Drainage Services business units and, accordingly, has structured its report in three major sections: (1) common initiatives that are being pursued by Water Services and Drainage Services together; (2) specific initiatives for Water Services, and; (3) specific initiatives for Drainage Services.

EWSI presents the initiatives for both the Water Services and Drainage Services business units within the following six specific strategic areas of focus:

- 1. Customer Service
- 2. Public Health/Environment
- 3. Employee and Public Safety
- 4. Employee Development
- 5. Operational Performance
- 6. Growth and Financial Performance

A large number of initiatives planned in 2021 have been carried over from EWSI's 2020 Operating Plan, as the impact of the COVID 19 pandemic has delayed the original timelines.
