# Bylaw 19367 - To Amend Bylaw 12294, EPCOR Edmonton Regulated Utilities Procedure Bylaw

# **Purpose**

Bylaw 19367 repeals the current Bylaw 12294 EPCOR Edmonton Regulated Utilities Procedures Bylaw, which sets out the process for Council to approve rates applicable to any utility service provided by EPCOR, within the boundaries of the City of Edmonton, that the City has authority to approve. Financial and Corporate Services report FCS00306, also at the February 5, 2021, Utility Committee meeting, provides a proposed process and timelines schedule that would instead formalize the regulatory process for the performance based rates applications being submitted by EPCOR Water Services Inc. to establish customer rates for water services for the five year period April 1, 2022 to March 31, 2027, and for wastewater and drainage services for the three year period April 1, 2022 to March 31, 2025.

# Readings

Bylaw 19367 is ready for three readings.

A majority vote of City Council on all three readings is required for passage.

If Council wishes to give three readings during a single meeting, then prior to moving third reading, Council must unanimously agree "That Bylaw 19367 be considered for third reading."

## **Report Summary**

This report recommends three readings of Bylaw 19367.

#### Report

In February 2021, EPCOR Water Services Inc. ("EWSI") will be submitting performance based rates applications for approval by City Council to establish customer rates for water services for the five year period April 1, 2022 to March 31, 2027, and for wastewater and drainage services for the three year period April 1, 2022

to March 31, 2025. Financial and Corporate Services report FCS00306, also at the February 5, 2021, Utility Committee meeting, provides the proposed regulatory process for Utility Committee and City Council to assess the reasonableness of the rates applications.

Bylaw 19367 repeals the current Bylaw 12294 EPCOR Edmonton Regulated Utilities Procedures Bylaw which sets out the process for Council to approve rates applicable to any utility service provided by EPCOR, within the boundaries of the City of Edmonton, that the City has authority to approve. The proposed process and timelines schedule provided in the February 5, 2021, Financial and Corporate Services report FCS00306 would instead formalize the regulatory process for the performance based rates applications to set customer rates effective April 1, 2022. The new regulatory process for all of the EWSI performance based rates applications will be more streamlined and does not require a bylaw.
