A Bylaw to amend Bylaw 12800, as amended, The Edmonton Zoning Bylaw <u>Amendment No. 2783</u>

WHEREAS a portion of NE, NW, SE, and SW-17-51-24-4; located at 10821 - 30 Avenue SW, Cavanagh, Edmonton, Alberta, is specified on the Zoning Map as (AG) Agricultural Zone; and

Appendix I of the North Saskatchewan River Valley and Ravine System Protection Overlay, being Section 811 to Bylaw 12800 The Edmonton Zoning Bylaw is hereby amended by:

- a. removing the lands legally described as a portion of NE, NW, SE, and SW-17-51-24-4; located at 10821 30 Avenue SW, Cavanagh, Edmonton, Alberta which are shown as "AG to RMD" and "AG to AP" on the sketch plan attached as Schedule "A" from the area of application of the North Saskatchewan River Valley and Ravine System Protection Overlay; and
- b. including the lands legally described as a portion of NE, NW, SE, and SW-17-51-24-4; located at 10821 30 Avenue SW, Cavanagh, Edmonton, Alberta which are shown as "AG to A" on the sketch plan attached as Schedule "A" in the area of application of the North Saskatchewan River Valley and Ravine System Protection Overlay.
