

Jurisdictional Scan (Summarized)

Jaywalking

Edmonton	5590 - Traffic - Jaywalking 59 A pedestrian shall not cross, or attempt to cross, a roadway other than within [a crosswalk, and not within a crosswalk when prohibited.]
Calgary	26M96 - Traffic 6. (1) A pedestrian shall not cross a street within one block in any direction of a traffic control signal or pedestrian corridor other than in a crosswalk.
Vancouver	2849c - Street and Traffic 12.(1) Every pedestrian [outside of a crosswalk], shall give the right-of-way to all vehicles upon the roadway. (2) No pedestrian shall jaywalk on a roadway.
Toronto	1184_950 - Traffic and Parking 950-302. Where an authorized sign to that effect is displayed, no pedestrian shall enter on or cross the roadway of the highways set out Schedule III in § 950-1302 at the locations set out in Schedule III.
Saskatoon	7200 - Traffic 37. (1) A pedestrian shall not cross a street within one block from a traffic signal except at a crosswalk.

Ride Bike on Sidewalk

Edmonton	5590 - Traffic - Ride Bike on Sidewalk 49 (1) A person shall not ride a bicycle, e-bike or e-scooter on any sidewalk.
Calgary	26M96 - Traffic 42. (1) Except as otherwise provided in this Section, a person shall not ride a bicycle; *Exceptions apply
Vancouver	2849c Street and Traffic 60. No person shall ride any bicycle upon any sidewalk except where posted by signs.
Toronto	1184_950 Traffic and Parking 950-300. F. No person shall ride upon or operate a bicycle, ... or any similar device on a sidewalk recklessly or negligently or at a speed or in a manner dangerous to the public, having regard to circumstances.
Saskatoon	9705 Bicycle 8. No person over the age of 13 shall operate a bicycle on a sidewalk unless the sidewalk is designated as a shared-use path...; or the person is temporarily crossing the sidewalk [to enter or exit] adjacent land.

Proof of Payment (Fare Evasion)

Edmonton	8353 - Conduct of Transit Passenger - Proof of Payment 5 A person in a Proof of Payment area must have valid Proof of Payment [and be able to present it when requested to do so by Officers or ETS]
Calgary	4M81 - Transit 9. (1) Any person who is found boarding or using a transit vehicle or entering or within a Restricted Fare Area and who fails to produce to an Officer upon demand a valid ticket is guilty of an offence.
Vancouver	Tariff Bylaw - Translink 5(a) [a person must] (v) possess Proof of Payment for the entire duration of his or her journey; and (vi) present Proof of Payment to any Transit Employee upon request.
Toronto	TTC By-law No 1 2. Requirement to Pay Fare - Conditions of Use 2.1 No person shall [be on or attempt to be on Transit property] without paying the appropriate fare:

Loitering

Edmonton	8353 - Conduct of Transit Passenger - Loitering 12 A person shall not loiter on Transit Property or in a Transit Vehicle for longer than required to reach their destination
Calgary	54M2006 - Public Behaviour 6. (1) No person shall loiter in a public place and thereby obstruct any other person.
Vancouver	BY-LAW NO. 2849 A By-law to Regulate Traffic and the Use of Streets 70. No person shall stand or loiter on any street in such a manner as to obstruct or impede or interfere with traffic thereon
Toronto	TTC By-law No 1 3.24 No person, unless otherwise authorized, shall loiter in or on TTC property.

Harassment

Edmonton	8353 - Conduct of Transit Passenger - Harassment 10 A person shall not molest or interfere with the comfort or convenience of any other person on Transit Property.
Calgary	4M81 - Transit 14. (1) No person shall, in or upon any [transit property]: (a) ...urinate or defecate; (b) fight; (c) engage in an activity which would molest or interfere with the comfort, convenience or quiet use and enjoyment of the transit system..; or (d) behave in a manner that would cause a safety concern...
Vancouver	Tariff Bylaw - Translink 4. (a) TransLink reserves the right to refuse to carry... (i) any person who is sick, intoxicated, boisterous, disorderly or profane, or who for any other reason may be offensive or dangerous or pose a risk to others or their property; (v) anything... that... might cause inconvenience to others, soil or damage transit property, or represent a safety hazard;
Toronto	TTC By-law No 1 3.25 No person shall cause a disturbance or act contrary to the public peace on TTC property, including but not limited to: a) urinating, expectorating or defecating, except in facilities specifically intended for such actions; b) using profane, insulting or obscene language or gestures; c) behaving in an indecent or offensive manner; d) shining any type of light at an operator of a TTC vehicle or any other passenger; e) fighting; or f) behaving in a manner which would interfere with the ordinary enjoyment of persons using the transit system.
Saskatoon	Only a policy posted on the website. Non-compliance will result in removal from the bus.

Urination and Defecation

Edmonton	14614 - Public Places - Urination and Defecation 5 A person shall not urinate or defecate in a public place except in a facility designed and intended for such use.
Calgary	54M2006 - Public Behaviour 4. No person shall defecate or urinate in or on a public place or in public on any private property.
Vancouver	Health Bylaw 9535 2.1 A person must not expectorate, urinate, or defecate on or in any street or other public place, except in a location in a public building or facility provided specifically for such purpose.
Toronto	743-9. Fouling and obstruction streets. 24 Unless specifically authorized by this Chapter: A. No person shall ...[permit or cause the] fouling of any street, ... except as permitted under this chapter or any other City by-law.
Saskatoon	8354 Spitting, Urination and Defecation 4. No person shall defecate or urinate in public on any private property or in or on a public place.

Littering

Edmonton	14614 - Public Places - Littering 4 A person shall not leave any garbage, litter or other refuse in a public place except in a receptacle designed and intended for such use.
Calgary	20M88 Street Bylaw 17 No person shall dispose of Litter on any portion of a Street. 11M2019 Parks and Pathways Bylaw 13. (1) A person must not dispose of waste in a park, unless: (a) it is placed in a designated waste receptacle, *exceptions for cultural ceremony as permitted
Vancouver	2849c Street and Traffic 84. (1) No person shall deposit upon any street or other public place, any rubbish, sweepings, leaves, construction or demolition debris, paper, handbills, refuse or other discarded materials or things.
Toronto	1184_548 Littering 548-3. A. No person shall [cause or permit] any waste on any highway within the City... or on any land not including buildings, within the City,
Saskatoon	8310 Waste 4. No owner or occupant of any [property] shall allow waste... to accumulate in or on the [property], except as permitted in this Bylaw. Depositing Waste on Public or Private Property 5. No person shall dispose of waste anywhere in the City other than in a waste container or at a Provincially-approved Waste Management Centre.
