# Dormancy Process for 2492369 Canada Corporation (aka Waste RE-solutions Edmonton)

**Public Consultation Results** 

## Recommendation

That Executive Committee recommend to City Council:

That the representations received from the public on the material change of the for-profit corporation, 2492369 Canada Corporation (aka Waste RE-solutions Edmonton), as set out in Attachment 1, be provided to the corporation's shareholder.

# **Executive Summary**

In accordance with the *Municipally Controlled Corporations Regulation,* the City has to follow this process in order to put their for-profit corporation into dormancy. The public needs an opportunity to comment on the material change to the corporation. These comments need to go to Council who then has to send a summary of the comments to the Shareholder.

# Report

2492369 Canada Corporation (aka Waste RE-solutions Edmonton) has concluded all business which it was previously involved in. As such it no longer needs to be an active corporation. After this process has been concluded and based on any additional information that is provided from the public, this corporation will become dormant. It is more cost effective to make this corporation dormant than to wind this for-profit corporation up.

This means that there will be a change in the board of directors from external board members to internal city administration, which will require a corporate bylaw amendment. Such a corporate bylaw amendment needs to be approved first by the Board of Directors and then by the Shareholder.

A dormant corporation still requires an electronic annual general meeting with the Shareholder and the board of directors. In addition, the required annual Federal and Dormancy Process for 2492369 Canada Corporation (aka Waste RE-solutions Edmonton) - Public Consultation Results

extra-provincial (Alberta) corporate filings will continue (for a nominal cost), including the annual corporate tax return but otherwise this corporation will be dormant.

Pursuant to the requirements of the *Municipally Controlled Corporations Regulation*, the City of Edmonton ran two ads in the Edmonton Journal on January 28 and on February 4, 2021, seeking public input into the proposed material change making this for-profit corporation dormant. A telephone number was provided in the ads and any comments from the public were recorded during the 30 day period in the voicemail and have been summarized in Attachment 1.

Residents have also been invited to speak to this matter at the March 22, 2021, Executive Committee meeting.

2492369 Canada Corporation, operating as Waste RE-solutions Edmonton, will no longer be carrying on active business and will remain dormant for the foreseeable future.

## **Budget/ Financial**

All residual funds, estimated at \$378,000 (Canadian dollars) will be returned to the City of Edmonton once final accounts are settled, this includes the 2020 declared dividend of \$190,686 approved by the Board of Directors.
