Castle Downs Family YMCA Funding Agreement

Recommendation

That the funding agreement between the City of Edmonton and the YMCA of Northern Alberta for one-time funding of up to \$1 million, as outlined in Attachment 1 of the March 24, 2021, Citizen Services report CS00256, be approved, and that agreement be in form and content acceptable to the City Manager.

Executive Summary

In December 2020, City Council approved up to \$1 million to be provided to the YMCA of Northern Alberta to support the reopening of the Castle Downs Family YMCA in 2021. Community and Public Services Committee approval of the agreement is required as the value falls outside the delegated authority for the City Manager.

Report

In December 2020, City Council approved funding of up to \$1 million for the YMCA of Northern Alberta to support the reopening of the Castle Downs Family YMCA in 2021 when it is appropriate to do so. Upon easing of Government of Alberta public health restrictions, the YMCA of Northern Alberta intends to reopen the Castle Downs Family YMCA as soon as it is able to while observing all recreation facility health guidelines as required by the provincial government. Key terms and conditions (Attachment 1) include recommended payment timelines and values. The funds will support the reopening of the Castle Downs Family YMCA as well as ongoing operations throughout 2021.

Budget/Financial Implications

During the Fall 2020 operating budget deliberations, the 2021 operating expenditure budget for the Community Recreation Facilities branch was increased by up to \$1 million on a one-time basis for funding to be provided for the YMCA of Northern Alberta to support reopening at the appropriate time of the Castle Downs Family YMCA in 2021, with funding from the COVID specific funds set aside in the Appropriated Financial Stabilization Reserve. Upon execution of the agreement and receipt of required reporting requirements, funding will be distributed as per the terms of the agreement.

Public Engagement

Public engagement was not conducted as the funding was previously approved by City Council.
