

# Council Calendar Changes

## June Recess and Agenda Review Committee Timing

### Recommendation

1. That the recess currently scheduled from June 7 to June 11, 2021, be rescheduled to May 31 to June 4, 2021.
2. That the May 18, 2021, Agenda Review Committee meeting be rescheduled to May 25, 2021, from 9:00 to 9:30 a.m.
3. That the May 31/June 2, 2021, City Council meeting be rescheduled to June 7, 2021, from 9:30 a.m. to 5:30 p.m., with continuation on June 9, 2021, from 9:30 a.m. to noon.
4. That the June 1, 2021, City Council Public Hearing be rescheduled to June 8, 2021, from 1:30 to 9:30 p.m.
5. That the June 2, 2021, Community and Public Services Committee - Non-regular meeting for the Youth Council Chair Interview and Shortlisting be cancelled..
6. That the June 3, 2021, Emergency Advisory Committee meeting be rescheduled to June 10, 2021, from 1:30 p.m. to 3:30 p.m.
7. That the Orders of the Day for the June 22, 2021, Agenda Review Committee meeting be changed from 9:00 to 9:30 a.m. to 8:45 to 9:15 a.m.
8. That an Agenda Review Committee meeting be scheduled on July 6, 2021, from 8:30 to 9:30 a.m., to discuss the quarterly lookahead.
9. That the Orders of the Day for the July 27, 2021, Agenda Review Committee meeting be changed to adjourn at 9:30 a.m. instead of 10:00 a.m., and no longer include the quarterly lookahead.

## **Report**

This report recommends changes to the 2021 Council Calendar to accommodate the Federation of Canadian Municipalities (FCM) Annual Conference and to adjust the timing of some Agenda Review Committee (ARC) meetings.

On October 5, 2020, City Council approved the 2021 Council Calendar. At that time, the dates for the 2021 FCM Annual Conference had not been finalized. The FCM has since confirmed that its Annual Conference will be held from June 1 to 4. To accommodate Member of Council participation in the conference, Administration recommends rescheduling the June recess, currently set for the week of June 7, to the week of May 31. Consequently, the meetings scheduled for the week of May 31 would need to be rescheduled to the week of June 7.

Additionally, Administration recommends a few changes to the timing of ARC:

- On June 22 to allow time between ARC and City Council.
- On July 6 and July 27 to adjust when the quarterly lookahead will occur.

Administration is also recommending that the June 2, 2021, Community and Public Services Committee - Non-regular meeting for the Youth Council Chair Interview and Shortlisting be cancelled. The Youth Council Chair will meet with Community and Public Services Committee at the June 16, 2021, regular meeting instead.
