- 5. Bylaw 7907, Bylaw to authorize a Memorandum of Understanding and a land lease with the Government of Canada for the provisions of aviation services required to operate the Edmonton Municipal Airport, is repealed.
- 6. Bylaw 7970, Bylaw to authorize an agreement with the Province of Alberta for lease of hangar space at the Edmonton Municipal Airport, is repealed.
- 7. Bylaw 9583, A Bylaw to approve an Agreement with Her Majesty the Queen in Right of Canada Regarding the Canada Customs Services Cost Recovery Agreement at the Edmonton Municipal Airport, is repealed.
