Purpose

To amend Schedule B and Schedule C of Bylaw 18589 - 2019 Business Improvement Area Assessment, Supplementary Business Improvement Area Assessment, Business Improvement Area Tax, Supplementary Business Improvement Area Tax and Business Improvement Area Tax Rate Bylaw to reflect the correct minimum tax and tax rate for Alberta Avenue Business Improvement Area.

Readings

Bylaw 18762 is ready for three readings.

Passage of this Bylaw is required by February 5, 2019, to facilitate the mailing of the Business Improvement Area Assessment and Tax Notices on February 15, 2019, to meet the March 31, 2019, payment due date.

If Council wishes to give three readings during a single meeting, then prior to moving third reading, Council must unanimously agree "That Bylaw 18762 be considered for third reading."

At the January 22, 2019, City Council meeting, Bylaw 18589 - 2019 Business Improvement Area Assessment, Supplementary Business Improvement Area Assessment, Business Improvement Area Tax, Supplementary Business Improvement Area Tax and Business Improvement Area Tax Rate Bylaw, received three readings.

Report

On January 22, 2019, City Council passed Bylaw 18589 - 2019 Business Improvement Area Assessment, Supplementary Business Improvement Area Assessment, Business Improvement Area Tax, Supplementary Business Improvement Area Tax and Business Improvement Area Tax Rate Bylaw.

Subsequent to the passing of Bylaw 18589, an error was discovered in the information on Schedule B and Schedule C to the Bylaw, relating to the minimum tax and tax rate for Alberta Avenue Business Improvement Area. The minimum tax for Alberta Avenue should read \$250 instead of \$150 As a result of this correction a change in the tax rate is also required, from 1.94122% to 1.90253%.

This amending bylaw updates Schedule B and Schedule C of Bylaw 18589 to properly reflect the minimum tax and tax rate for Alberta Avenue Business Improvement Area.
