## BYLAW 19732 <br> TAX PENALTY, INTEREST AND MONTHLY PAYMENT BYLAW AMENDMENT NO. 2

Edmonton City Council enacts:

1. Bylaw 19394, Tax Penalty, Interest and Monthly Payment Bylaw is amended by this bylaw.
2. The following Section 10(4) is added after Section 10(3):

10(4) Subsection (1) does not apply to any businesses paying business improvement area tax for the 2021 taxation year and refund cheques will be automatically issued if there is an overpayment for those businesses.
3. Section 13(4) is added after Section 13(3):

13(4) For the 2021 taxation year, Section (2) does not apply for any applications received between April 21 and December 31.
4. Schedule "A" is deleted and replaced by Schedule "A" attached to this bylaw.
5. This bylaw comes into force on the date it is passed and is retroactive to April 21, 2021.
