- 3. The following Section 4(4) is added after Section 4(3):
 - 4(4) Notwithstanding Section 4(1), the due date for the annual 2021 taxes for Leduc Annexed Residential Properties is December 31, 2021 and no penalties shall be charged on current taxes in 2021.
